BACKGROUND:

Summary (continued)

1. **Community Outreach Ministry - \$1,000** – the funding will be utilized for food, clothing and holiday needs of children whose parents are incarcerated.
2. **Rose Again Foundation - \$2,500** – will be used to help purchase new shoes for 100 local foster children living in the South West Riverside County area for the holiday season.
3. **Feeding America Riverside / San Bernardino - \$5,000** – the funding will be allocated for the Child Hunger program which provides nutritious, healthy food to low income students and their families one school day each month.
