BACKGROUND:

Summary

Change of Zone Case No. 7811 (CZ 7811) changes the zoning from Manufacturing-Service Commercial (M-SC) and Industrial Park (I-P) to One Family Dwellings (R-1) on approximately 65 acres. The public hearing for CZ 7811 was held on September 1, 2015 as Agenda Item No. 16-2. At the conclusion of public testimony, the Board of Supervisors closed the public hearing, adopted a Mitigated Negative Declaration for Environmental Assessment No. 42636 and tentatively approved CZ 7811. Pursuant to Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts. Adoption of Ordinance No. 348.7812 will finalize the Board's tentative action on CZ 7811, formally change the property's zoning classification and amend the County's zoning map to reflect the new zoning classification

On September 1, 2015, the Board also approved Tentative Tract Map No. 36668, a Schedule "A" subdivision of the 65 acre project site into 200 residential lots on 37.82 acres, two (2) park sites on 4.1 acres, three (3) proposed water quality basins on 2.54 acres, eleven (11) open space and recreational lots on 1.11 acres and 17.09 acres for in-site infrastructure development.

The property is located southerly of Center Street and easterly of California Avenue.

Impact on Citizens and Businesses

The impacts of processing Change of Zone Case No. 7811 and adoption of this ordinance have been evaluated through the environmental review and public hearing process by staff, the Planning Commission and the Board of Supervisors. The opportunity for public review and comment was provided during the public hearings scheduled for this change of zone and any verbal or written testimony provided by the public was considered by the hearing body at that time. Today's action will finalize the Board's tentative action that was taken on September 1, 2015 pursuant to Agenda Item No. 16-2 and formally change the property's zoning classification.







Vicinity Map


