

California resource conservation districts (RCDs) are established, governed and authorized under Division 9 of the Public Resources Code. RCDs work to conduct:

- Watershed planning and management
- Water conservation, quality protection and enhancement
- Agricultural land conservation
- Wetland and wildlife conservation and habitat enhancement
- Recreational land restoration
- Conservation education

One qualified candidate has applied to fill the vacancy, Lin Juniper.

Lin Juniper has a passion for and experience in environmental stewardship. She currently serves on the board of directors for the Friends of Desert Mountains, which works to protect and restore natural lands and habitat for the Santa Rosa-San Jacinto National Monument. She also helped develop the Environmental Leadership Academy at Cal State San Marcos that educates participants on issues related to land, water, waste, energy, air and transportation, a program with which she remains involved. Prior to retiring, Ms. Juniper worked for Southern California Edison siting and licensing the construction of facilities with various government agencies.
