BACKGROUND:

Summary (continued)

The State initially budgets federal highway fund availability for six fiscal years. Time extensions may be requested to increase the funding availability to eight years. This time extension request is for funds currently having a state expenditure deadline of June 30, 2016. Caltrans is advising that a time extension be sought for all funds which may not be invoiced by December 31, 2015.

Federal funds for the environmental document phase of the project to replace the Mission Boulevard Bridge over the Santa Ana River were budgeted by the State in FY 2010/2011 and were authorized for expenditure on August 30, 2011. The unexpended balance at the time Caltrans' prepared the funding notice was \$1,798,880. The environmental process is not expected to be completed until 2018, and therefore a time extension is needed.

The County of Riverside Transportation Department (Transportation Department) began coordination with Caltrans for replacement of the Mission Boulevard Bridge over the Santa Ana River, prior to the July 1, 2011 incorporation of the City of Jurupa Valley. The Transportation Department has continued to serve as the lead agency for the project by request from the City of Jurupa Valley and the City of Riverside, which was approved on September 1, 2015 (Agenda Item 3-26) by the Board of Supervisors. Federal funds will provide 88.53% of the funding for the environmental document phase and local matching funds of 11.47% are needed. The project was delayed due to the new City of Jurupa Valley's delay in committing its jurisdictional share of matching funds until recently.

Federal funds for construction of Phase 1 Widening of State Route 79 (Winchester Road between Scott Road and Domenigoni Parkway) were budgeted by the State in FY 2010/2011 and were authorized for expenditure on August 12, 2011. The construction contract was awarded by the Board of Supervisors on November 22, 2011 (Agenda Item 3-15). The unexpended balance at the time Caltrans' prepared the funding notice was \$1,445,424.

Several issues delayed and are currently delaying the project's completion. Physical construction is essentially complete; however, ongoing arbitration between the contractor and their materials supplier has stopped construction payments to the contractor and is delaying project closeout. Earlier delays during construction, from unforeseen circumstances, included unexpected rock blasting, late utility company execution of work, and finding subsurface cultural artifacts, which triggered an additional environmental clearance and mitigation action. Additional unplanned extra work included: a change in median barrier type, traffic signal safety upgrades, guardrails in 10 added locations, increasing the road base and asphalt thicknesses, and addition of a drainage channel system for better protection of private property.

Once arbitration is resolved, construction payments can be completed. The project close-out process and final invoicing to Caltrans for federal funds will not finish prior to December 31, 2015, and a time extension is needed.

Phase 2 Widening of State Route 79 (Winchester Road between Abelia Street and Scott Road), is also waiting final close-out and is being funded and tracked as a separate project.

The Director of Transportation and Land Management has transmitted the attached time extension request documents to Caltrans in order to meet their response deadline. Board of Supervisors' concurrence is necessary for the State to approve the time extension requests.


