Summary (continued)

1. **Riverside County Economic Development Agency- Neighborhood Enhancement Program –**
The Clean Neighborhoods program is designed to reduce blight in the communities of Aguanga, Anza Valley, East Hemet, Homeland, Idyllwild, Lake Riverside, Mountain Center, Pine Cove, Pine Meadow, Valle Vista and Winchester. The funding will assist approved clean-up projects for residential properties. In exchange for the funded project, the applicant must agree to maintain the property improvements, funded by this program, for a minimum period of 60 months.
