BACKGROUND:

Summary

The Probation Department approved a request to initiate a project to make necessary upgrades to the IJH HVAC system for Units 3 and 5. The HVAC units were installed in 1978 and have been regularly maintained; however, they have exceeded their functional life expectancy resulting in intermittent malfunctions. In an effort to avoid inevitable system failures and critical downtime, the Economic Development Agency (EDA) proposed upgrades to the HVAC system which consist of replacing two air handlers and all associated components such as piping, three-way valves, thermostats, two larger exhaust fans with enlarged ductwork that service the showers in both units; replace and rewire two HVAC units, one for the gym and one that serves the Mental Health Administration Office to comply with State and Federal code regulations.

The work includes, but is not limited to, electrical upgrades required for the larger air handler motors; replacement of a broken magnetic starter and defective bucket (housing cam) in the main motor control center panel that provides power to the multi zone air handler which services the kitchen, cafeteria and main hallway; repair fire/life safety controls, hot and chilled water controls; replace failed control system for the multi zone unit; and upgrade lighting in Units 3 and 5 to bring into current code compliance. EDA will deliver the project utilizing the Job Order Contracting (JOC) method; JOC No. 006, with Pub Construction. Time is of the essence to bring the facility up to code.

Impact on Citizens and Businesses

The Probation Department's Indio Juvenile Hall provides important public safety services to the region. Replacing the air handlers and HVAC units and repairing the fire/life safety controls will avoid system failures and provide improved levels of cooling and heating in compliance with State and Federal code regulations.
