BACKGROUND:

Summary (continued)

1. The donation to Feeding America Riverside/San Bernardino will be used to fund their child hunger program, which provides nutritious, healthy food to low income students and their families one school day each month.
2. The donation to Kids Court and Counseling Center will be used to provide counseling to children, aged 5-18, to help them alleviate their fears and anxiety of having to testify in court. These services are offered to children who have to testify in family law, civil, criminal and juvenile court.
3. The donation to Home Gardens Academy will be used to sponsor their "What if we served other" day, where students will be participating in neighborhood clean-ups, writing letters to military members, painting graffiti and distributing food baskets to needy families. This donation would help cover the cost of needed supplies to carry out this event.
4. The donation to the Riverside Arts Council will be used to sponsor their Arts and Minds program, which gets art in schools, provides art as gang prevention and art as therapy.
