Born on December 29, 1927 in Davenport, Iowa, Betty had a deep faith in God, was generous in extending hope and courage to others, and lived a full life abundant with hospitality, humor, and adventure. A true humanitarian, she traveled to almost every continent teaching children, reaching out to adults, and always planting the seeds of peace and friendship.

In 1951, Betty married Paul Rosentrater and they began making plans for a family and Mission work which took them to the Navajo Tribal Nation in New Mexico and Cuernavaca, Mexico. After Mexico, they moved to Kansas City and were en route to Nappanee when Paul fell ill. When he died in 1962, she raised their five children in Nappanee.

Returning to the classroom as a Special Education teacher, Betty eventually settled into a 28-year-career as an elementary teacher. She was one of the first educators in the Wa-Nee school system to be granted a sabbatical as a teacher in the American Nicaraguan School in Managua, Nicaragua. Bringing her four youngest children with her, she spent weekdays educating the sons and daughters of ambassadors from around the globe with Nicaraguan elite and American business reps from cotton, tobacco, and other Nicaraguan export commodities.

After retiring, Betty joined the Peace Corps. She lived and taught in Honduras and also spent a year on the African continent teaching at the US Embassy School in Cameroon. Other service-oriented travels included a tour of Russia and Poland, a Friendship Force tour of Australia and New Zealand, and a six-month stint as a Guest House Manager for World Gospel Mission in Bolivia.

Betty was a loving and devoted wife, mother, grandmother, great-grandmother, sister, and friend. Her memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be dearly missed but never forgotten.



He attended the University of Florida, graduated from Temple University in 1957, and served in the U.S. Army Reserves. In 1961 he moved to Sacramento, California with his wife Nancy and began working for the State of California.

A "civic-minded leader" in his profession, Dick was known as the "Father of Affirmative Action in California" when he led the path to change recruitment procedures at all levels of government by removing cultural biases from civil service exams and altering educational requirements to attract minority workers to public service opportunities. He later organized the creation of the California African American Museum at Exposition Park in Los Angeles while serving as Deputy Director of the State & Consumer Services Agency. As head of the California Conservation Corps in the nineties, he helped troubled youth turn their lives around.

An instrumental force in the community, Dick was an active board member for decades for Congregation B'nai Israel, Sacramento Personnel Association, Home of Peace Cemetery, and Planned Parenthood. He also served as the Committee Chair of Boy Scout Troop 1 and on the Investment Committee for the Jewish Community Foundation of the West.

After retiring from the California Conservation Corps in 2000, Dick enjoyed traveling, fishing, and spending quality time with family and friends. An avid art collector for over 50 years, he found new hobbies in jewelry making, painting, and ceramics.

In 1983, as part of a series to promote the building of a theatre audience in the desert, Sidney encouraged Charlotte to stay in the desert and co-star in "Death of A Salesman" opposite Nehemiah Persoff at the Anenberg Theater, directed by the College of the Desert's Terry Nicholson. Later she played Fonsia in "The Gin Game" (for which she won 'Best Actress' at the Desert Theatre League Awards) and Daisy in "Driving Miss Daisy" both at COD with Nicholson as director.

Charolette's memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be dearly missed but never forgotten.
