BACKGROUND: Community Improvement Designation funds will be given to:

- 1. Oak Grove Center for Education Treatment and the Arts - \$1,000** funding will be used to support services to the youth in the First District. Oak Grove is an educational and residential center serving youth who experience social, emotional and behavioral disorders, neurological or medical problems, family dysfunction and chemical dependency.
- 2. Citrus Hills High School Girls Volleyball Teams - \$1,000** funding will be used to support the Citrus Hills girls volleyball program purchase equipment.
- 3. Family Services Association - \$1,000** funding will be used to support FSA's Hope for the Holidays program that provides support to foster youth during the holiday season. The funds will be designated for foster youth in the First District.
- 4. Riverside National Cemetery Memorials & Monuments Committee - \$1,000** funding will be used towards the construction of an American Indian & Alaska Native Veterans Memorial Monument at the Riverside National Cemetery.
