SUMMARY OF EVIDENCE

- 1. Documents of record in the Riverside County Recorder's Office identify the owner of THE PROPERTY as Dorothea Laub ("OWNER"). THE PROPERTY is occupied by Derrick Laub ("OCCUPANT").
- 2. Documents of title indicate that no other parties appear to potentially hold a legal interest in THE PROPERTY.
- 3. THE PROPERTY was inspected by Code Enforcement Officers on February 3, 2015 and on seven (7) subsequent follow up inspections, with the last being October 19, 2015.
- 4. During each inspection an accumulation of rubbish and excess outside storage was observed throughout THE PROPERTY consisting of but not limited to: tools, equipment, automotive parts, furniture, cleaning supplies, lumber, appliances, cardboard boxes, bags of trash, household garbage and waste, of about 1,000 square feet.
- THE PROPERTY was determined to be in violation of Riverside County Ordinance
 Nos. 348 and 541 by the Code Enforcement Officer.
- 6. On May 20, 2015, a Notice of Pendency of Administrative Proceedings was recorded at the Riverside County Recorder's Office as instrument number 2015-0209524.
- 7. On February 3, 2015, a Notice of Violation was posted on THE PROPERTY. On February 5, 2015, a Notice of Violation was mailed to OWNER and OCCUPANT by first class mail. On April 8, 2015, a Notice of Violation was mailed to OWNER by certified mail, return receipt requested.
- 8. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notice of the public hearing before the Board of Supervisors was mailed to OWNER and OCCUPANT and was posted on THE PROPERTY.

FINDINGS AND CONCLUSIONS

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on October 27, 2015, finds and concludes that:

1. WHEREAS, the excessive outside storage of materials and accumulation of rubbish on the real property located at 55599 Encino Road, Idyllwild, Riverside County, California, also

identified as Assessor's Parcel Number 567-112-009 violates RCO Nos. 348 and 541 and constitutes a public nuisance.

- 2. WHEREAS, the OWNER, occupants and any other person having possession or control of THE PROPERTY shall abate the accumulation of rubbish and excessive outside storage of materials by removing and disposing of all rubbish and excessive outside storage on THE PROPERTY in strict accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541 within ninety (90) days.
- 3. WHEREAS, the OWNER AND OCCUPANT ARE HEREBY FURTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

ORDER TO ABATE NUISANCE

IT IS ORDERED that the accumulation of rubbish and excessive outside storage of materials on THE PROPERTY be abated by OWNER or anyone having possession or control of THE PROPERTY by removing and disposing of all rubbish and excessive outside storage of materials on THE PROPERTY in strict accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541, within ninety (90) days of the posting and mailing of this Order to Abate Nuisance.

IT IS FURTHER ORDERED that if the accumulation of rubbish and excessive outside storage of materials are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541 within ninety (90) days of the date of this Order to Abate Nuisance, the accumulation of rubbish and excessive outside storage of materials may be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.

IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code section 25845 and RCO Nos.




