

Summary (continued)

1. Voices / Joey's Pals - \$1,500 the funding will go towards Santa Comes to Our Valley Program in the Homeland and Romoland area. Children from low-income families receive holiday gifts.
2. Soroptimist International of Idyllwild's Annual Tree Lighting event - \$1,000 the allocation will fund the on-going project of "Save the Sequoia" by utilizing funds raised to purchase a water tank for the Sequoia and the Christmas Tree Lighting event for the Idyllwild community.
3. 4 Paws 4 Patriots - \$2,500 the funding will support basic service dogs for veterans.
4. Habitat for Humanity Inland Valley - \$1,000 for the "Brush of Kindness Program" that helps elderly and challenged income families to receive minor home repairs.
5. Time is Creeping Up Productions, (TICUP) - \$700 for foster youth holiday dinner.
