

BACKGROUND: Community Improvement Designation funds will be given to:

1. **League of United Latin American Citizens of Riverside Council #3190 - \$1,500** funds will be used to assist the 4th Annual Free Community Health Fair. At this event, located in the 1st District, participants will receive free dental, vision and medical services. Up to 1,500 participants are expected to attend.
2. **Catholic Charities San Bernardino & Riverside Counties - \$1,000** funding will be used to support the Family Tragedy Fund that assists with burial assistance to families in need residing in the First District.
3. **Riverside Dickens Festival - \$1,000** funds will be used to support one of the signature events in Riverside-- the annual cultural festival celebrating the life and works of Charles Dickens and the Victorian Era. This event is free and open to the public.
