BACKGROUND:

Summary

1. All Things Are Possible provides music and motion therapy for special needs children including children with autism, bi-polar disorder, hearing and vision impairments and physical disabilities in the Coachella Valley, Desert Sands and Palm Springs Unified school districts. This program provides wheelchair dance, wheelchair band, singing and musical instruments. CID funds will be used toward scholarships for students to participate in this 28-week program.
2. The Red Hot Ballroom, Inc. is a non-profit after-school program providing students the opportunity to participate in dance instruction. This program is in 13 schools in the Coachella Valley Unified School District, 17 schools in the Desert Sands Unified School District and seven schools in the Palm Springs Unified School District. The dance program teaches social skills, self-esteem, respect for others and healthy physical exercise. At the end of the school year Red Hot Ballroom holds a dance competition among school districts. CID funds will be used for dance competition scholarships at \$75 per student for 40 students.
