BACKGROUND:

Summary (continued)

SECURE is a Multi-County effort and allows authorized statewide and national submitters to record documents electronically via a portal. The benefits of this portal include reduced cost to the involved counties, closer communication between Southern California title companies and service providers, and reduced confirmation times for title companies.

On July 29, 2008, Agenda item 3.17, the Board of Supervisor approved the Multi-County agreement allowing Riverside County to equally share the costs for acquisition, ongoing maintenance and software development upgrades among the four involved counties.

On November 6, 2012, Agenda item 3.15, the Board of Supervisors approved the first amendment to the Multi-County agreement extending Riverside County's cooperation and the SECURE system upgrade to a third version. The enhanced version has ongoing maintenance costs spanning three years, renewable in one year increments.

Approval of the second amendment will continue Riverside County's cooperation in the Multi-County SECURE system. The total cost is comprised of \$292,500 annually for system maintenance and a onetime charge of \$250,000 to incorporate the Government to Government (G2G) Portal, which will reside as a separate portal functioning under the same security framework and protocols as set forth by the Electronic Recording Delivery Act of 2004.

Additional Fiscal Information

The department does not anticipate any further costs for the G2G implementation. The agreement does not impact the General Fund and no budget adjustment is necessary. All Costs have been anticipated in the current year budget and funded through the Electronic Recording Delivery System reserve fund, as provided for in the Electronic Recording Delivery Act of 2004.

Impact on Residents and Businesses

The benefits of this portal include reduced cost to the participating counties, closer communication between Southern California title companies and service providers, and shorter confirmation times for title companies of recorded instruments.

SECOND AMENDMENT TO THE MULTI-COUNTY AGREEMENT BETWEEN THE COUNTIES OF LOS ANGELES, ORANGE, RIVERSIDE AND SAN DIEGO FOR THE SHARED OWNERSHIP AND ONGOING MAINTENANCE OF AN ELECTRONIC RECORDING DELIVERY SYSTEM

This Second Amendment to the Multi-County Agreement between the Counties of Los Angeles, Orange, Riverside, and San Diego for Shared Ownership and Ongoing Maintenance of an Electronic Recording Delivery System hereinafter referred to as the "Second Amendment," is made and entered into upon execution of all necessary signatures from the Counties of Los Angeles, Orange, Riverside, and San Diego, collectively referred to as the "Counties".

RECITALS:

WHEREAS, the Counties entered into the Multi-County Agreement Between the Counties of Los Angeles, Orange, Riverside, and San Diego for Shared Ownership and Ongoing Maintenance of an Electronic Recording Delivery System ("Agreement") on August 19, 2008; and

WHEREAS, under the First Amendment to the Agreement, effective July 1, 2012, the Agreement was amended, among other things, to: (i) enhance and upgrade the SECURE system to a new version known as SECURE Version 3; and, (ii) increase the maintenance costs in relation to the SECURE Version 3; and

WHEREAS, the Counties wish to further amend the Agreement to: (i) incorporate the Government to Government (G2G) Portal, which resides as a separate portal functioning under the same security framework and protocols as set forth by the Electronic Recording Delivery Act of 2004 in SECURE Version 3; (ii) clarify the costs associated with administering the G2G portal; and, (iii) authorize one-time cost recovery for SECURE Version 3 upgrade expenditures paid in 2013/14 and 2014/15.

NOW, THEREFORE, in consideration of the mutual obligations set forth herein, Counties mutually agree to amend the Agreement as follows:

1. Section 10 ("Additional parties") of the Agreement is amended to add an additional paragraph to read as follows:

Government agencies may participate in the use of SECURE system through the G2G Portal upon majority approval of the Counties. A government agency will participate by use of a separate Memorandum of Understanding Agreement created and approved by the Counties. In addition, fees and conditions for the use of the system by the government agency shall be determined and imposed by the Counties.

SUMMARY:

The Orange County Clerk-Recorder requests approval of the Second Amendment to the Multi-County SECURE Electronic Recording Delivery System Agreement to: (i) incorporate the Government to Government Portal, which was incorporated into SECURE Version 3 as a separate module for government to government recordings; (ii) clarify the costs associated with administering the Government to Government Portal; and, (iii) authorize a one-time cost recovery for SECURE Version 3 upgrade expenditures paid in FY 2013-14 and FY 2014-15.

BACKGROUND INFORMATION:

On February 5, 2008, the Board of Supervisors authorized the Orange County Clerk-Recorder to enter into a Multi-County Agreement with the Counties of Los Angeles, Orange, Riverside and San Diego to

share ownership, cost and maintenance of a multi-county electronic recording delivery system. This system eventually became known as SECURE.

On August 19, 2008, the Board of Supervisors authorized the Clerk-Recorder to execute a revised multi-county agreement with counties of Riverside, Los Angeles and San Diego for shared ownership and maintenance of an electronic recording delivery system known as SECURE.

The SECURE system allows certain organizations authorized under the California Government Code (title companies, escrow companies, financial institutions, government agencies and others) to electronically submit official documents to County Recorders for recording. Under the Multi-County Agreement, Orange County was designated the "Lead County" responsible for administering the contract, training new submitters, training partner counties, and maintaining the delivery system and network.

On June 26, 2012, the Board of Supervisors authorized the Clerk-Recorder to execute the First Amendment to the Multi-County Agreement. The First Amendment provided for the enhancement and upgrade of the SECURE system to a new version known as SECURE Version 3. It also provided for an increase in the annual not-to-exceed maintenance costs, which is assessed to each SECURE owner. This development and upgrade to SECURE Version 3 also required an upgrade to the computer network. As the Lead County which hosts the network, Orange County designed and built the new SECURE Version 3 network, which is currently housed at the Orange County Data Center. The Second Amendment authorizes Orange County to recover a contribution of \$250,000 from the other SECURE owners (Los Angeles, Riverside, and San Diego) to reimburse Orange County for costs incurred as Lead County for upgrading the SECURE Version 3 network. As the Lead County which built the new SECURE Version 3 network, Orange County's contribution to the network has already been expended.

The SECURE Version 3 system allows for the integration of a new Government to Government Portal within the security framework of the system. The Government to Government Portal allows government agencies at the local, state or federal level to submit legal documents to County Recorders for electronic recording. The Second Amendment will add contract language that allows the Lead County (County of Orange) to administer the government to government MOUs on behalf of other SECURE owner counties.

FINANCIAL IMPACT:

Revenue for this agreement is included in the FY 2015-16 Adopted Budget for Clerk-Recorder Special Revenue Fund 12D.
