He was also a dedicated LDS High Priest and always a strong believer in the power of prayer. He loved astronomy, computer programming, and rock collecting.

However, even though retired, he continued to serve the public by volunteering with the American Red Cross on disaster relief missions. He credited the Red Cross as having saved his life and those of the other POWs.

After school, he went back to Coachella Valley, with his wife Patricia Anne Baker and went into business with his parents who had developed a ranch in the Thermal area. Even after the passing of Ben's parents, Laflin Date Gardens continued to operate and is known today as Oasis Date Gardens.

Ben was a date grower, yet, in addition to dates, his ranch grew grapes and vegetable crops. He generously shared his knowledge of date culture with visiting plant scientists and date growers from Middle East, India, Africa and Australia. He made consulting trips for the United Nations Development Program, for USAID and at the request of individual governments and organizations. A highlight of his date travels was a visit to Morocco in 1995 when he and Pat were able to visit the oasis of Bou Denib, on the outskirts of the Sahara. This was the place from which the USDA secured nine Medjool offshoots in 1927, where all of the Medjools grown in the U.S. today have come from those nine imported offshoots.

Because he grew a wide variety of dates, he was able to showcase the breadth of our valley's date industry by furnishing both feature exhibits and displays for the Date Festival for over forty years. He lived a fulfilled life, having the career he enjoyed most, and the family he loved. He is survived by his wife Pat, and their five children. He will be missed.
