required to designate Pacific Grove to operate the facility as a LPS (5150) 72-hour treatment and evaluation site, and to authorize the Director of RUHS-BH to submit the LPS designation request to the DHCS.

**Impact on Citizens and Businesses**

The designation of Pacific Grove will provide twenty-four (24) additional acute care hospitalization beds for Riverside County constituents with severe mental illness, who require a 5150 designated facility for continued medical care and mental health treatment. These services are a component of the department's system of care aimed at improving the health and safety of consumers and the community.
