BACKGROUND:

Summary

The County Transportation Improvement Program (TIP) provides for construction of the Sidewalk Safety Project at Avenida Rambla (Bubbling Wells Elementary School to Camino Aventura) and Camino Campesino (Avenida Rambla to Bubbling Wells) in the Desert Hot Springs area of Riverside County.

This project proposes to construct approximately 2,300 linear feet of new sidewalk, including seven new access ramps and the retrofitting existing driveways. Traffic improvements include removal and replacement of existing signs and other work as may be necessary.

The submitted plans and specifications have been approved as to form by County Counsel, and environmental clearance is complete.

Project Numbers: C5-0076, State Project No. ATPL-5956(245)

Impact on Residents and Businesses

The proposed improvements will improve pedestrian safety by providing an Americans with Disabilities Act (ADA) compliant pedestrian path for extra space students and parents going to and from Bubbling Wells Elementary School.

The work is scheduled to begin in summer of 2016 while Bubbling Wells Elementary School is on summer break. The work will be phased to keep the road open during construction and will take approximately two months to complete.

SUPPLEMENTAL:

Additional Fiscal Information

The construction contract is estimated to cost approximately \$226,275. Construction is expected to finish in FY 2016/2017 and is funded with Gas Tax (ABX8-9 Mar 2010 New HUTA and the Active Transportation Plan (ATP). The State ATP funds are from a grant for which the Transportation Department successfully competed. There are no General Funds used in this project.

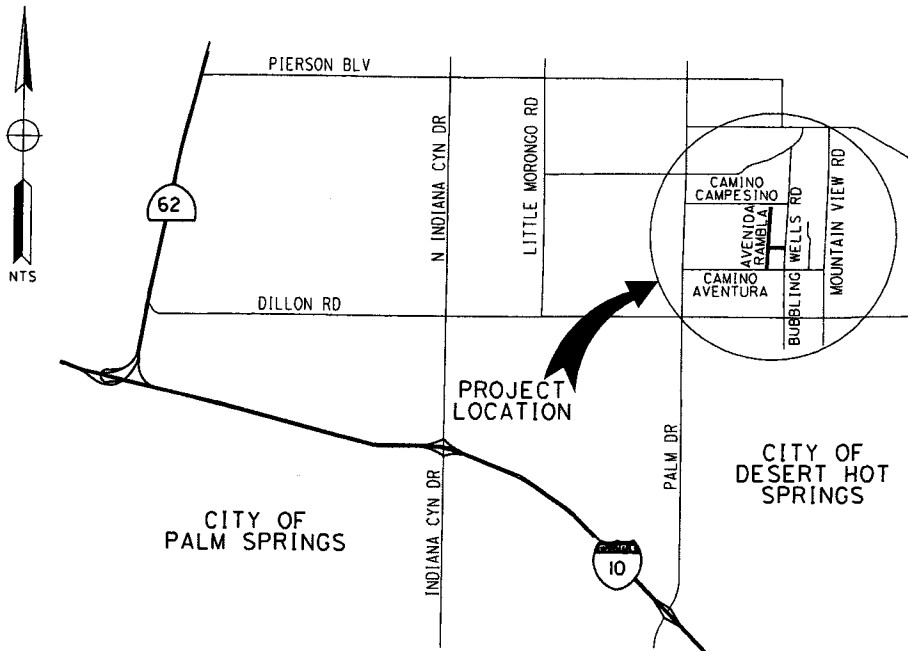
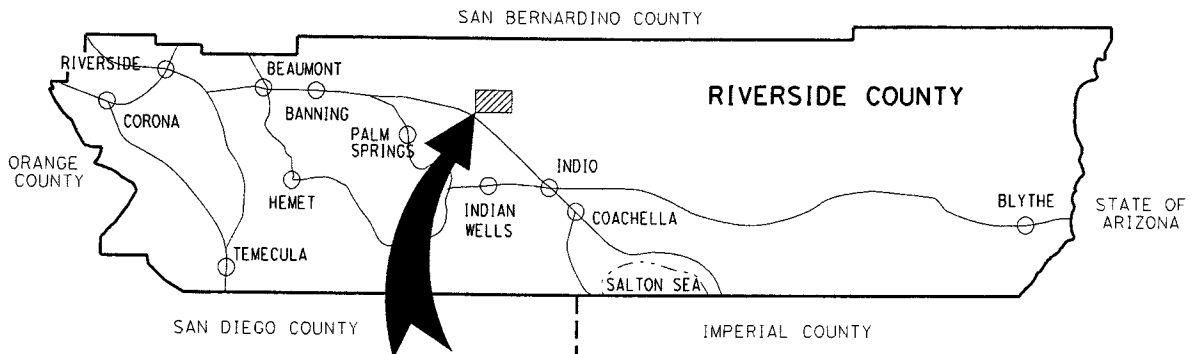

Each bid shall be in accordance with plans, specifications and other contract documents, dated **December 2015**, and prepared by County of Riverside, whose address is same as the above, from whom they may be obtained upon deposit of **\$20.00** per set with 24"x36" plans, plus mailing costs. No refund. Prospective bidders may preview the plans, specifications and other contract documents at no charge prior to purchase at the above noted location.

Pursuant to Labor Code section 1771.1, any Contractor bidding, or subcontractor to be listed on a bid proposal subject to Public Contract Code section 4104, shall not be qualified to bid after March 1, 2015, unless currently registered and qualified to perform public works pursuant to Labor Code section 1725.5. No Contractor or subcontractor may be awarded a contract or perform work on any contract for public work, after April 1, 2015, without proof of current registration with the Department of Industrial Relations pursuant to Labor Code section 1725.5 to perform public works.
