Authorize the Purchasing Agent, in accordance with Ordinance No. 459, based on the availability of fiscal funding, to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation provision that do not exceed the statutory limits as set forth in the Public Contract Code as approved by County Counsel.

BACKGROUND:

Summary

The County of Riverside is regulated by the National Pollution Discharge Elimination System (NPDES) Municipal Separate Storm Sewer System (MS4) permits applicable to three primary watersheds (Santa Ana River, Santa Margarita River, and Whitewater River). Pursuant to Clean Water Act Section 402(p)(3)(B)(iii), NPDES MS4 permits "...shall require controls to reduce the discharge of pollutants to the maximum extent practicable,..." The State Water Resources Control Board legal counsel addressed the maximum extent practicable (MEP) standard in stating:

"To achieve the MEP standard, municipalities must employ whatever Best Management Practices (BMPs) are technically feasible (i.e., are likely to be effective) and are not cost prohibitive. The major emphasis is on technical feasibility. Reducing pollutants to the MEP means choosing effective BMPs, and rejecting applicable BMPs only where other effective BMPs will serve the same purpose, the BMPs would not be technically feasible, or the cost would be prohibitive."

Equipment, materials (new and recyclable), and wastes are stored outside at each of the County of Riverside Transportation Department's (Transportation Department) District Road Maintenance Yards. These items may be rusty, corroded, greasy, or contain fluids that may leak or spill. Precipitation and storm water runoff may become polluted when contacting equipment, materials (new and recyclable), and wastes stored outside without appropriate and adequate BMPs. Storage in a designated area, on an impervious surface (concrete) that is covered by an awning prevents pollution of storm water runoff by eliminating contact.

Griffith Company is to construct ten concrete slabs (each 15 feet by 50 feet) and awnings to cover the concrete slabs at ten of the Transportation Department's District Road Maintenance Yards for a total price of \$195,000. Ongoing maintenance cost of the concrete slabs and covers will be borne by the Transportation Department. The road maintenance yards are located in all five Supervisory Districts.

Impact on Citizens and Businesses

Awnings and concrete pads for outside storage will minimize storm water pollution, thereby protecting the water resources of Riverside County. Due to the increasing likelihood of an El Nino weather pattern, the expedient construction of these concrete pads and awning coverings is desired.

Contract History and Price Reasonableness

Purchasing released a Request for Quotation, e-mailing solicitations to five (5) construction bid boards. Two (2) responses were received, with proposals submitted by two (2) vendors.

The two quotations were reviewed by department experts for material usage and overall price was evaluated by the procuring contract specialist. The Griffith Company was determined to be the most responsive, responsible bidder, and lowest priced. It is recommended the Griffith Company be given the award for the amount not to exceed of \$195,000.
