She and her bandleader, Bobby Ramos, developed and hosted one of the first weekly television musical variety shows in Los Angeles, named "Latin Cruise." Taking on her mother's maiden name, she changed her stage name and became known as "Lita Baron."

In the early 1970's, Lita moved to Palm Springs with her daughters and began a new phase in her career when she launched the popular radio show, "Lunch with Lita." When the radio show ended, she obtained her real estate license and did very well in real estate marketing. She retired in 2010 at the age of 87.

An instrumental force in the community, Lita was honored last February at the Palm Springs Art Museum for Modernism Week. She had been featured in the iconic Slim Aarons photograph, "Poolside Gossip" that was taken at the Kauffmann house in Palm Springs, designed by modernist architect Richard Neutra.

Lita's memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be greatly missed but never forgotten.
