17 The above-captioned matter came on regularly for hearing on December 15, 2015, before the  
18 Board of Supervisors of the County of Riverside, State of California in the Board Room, First Floor  
19 Annex, County Administrative Center, 4080 Lemon Street, Riverside, California regarding the real  
20 property described Parcel East of 68190 St. Mortiz Drive, Pinyon Pines, Riverside County,  
21 Assessor's Parcel Number 635-262-015 and referred to hereinafter as "THE PROPERTY."

22 Sophia Choi, Deputy County Counsel, appeared along with Michelle Cervantes, Senior Code  
23 Enforcement Officer, on behalf of the Director of the Code Enforcement Department.

24 Owner appeared but did not address the Board of Supervisors.

25 The Board of Supervisors received the Declaration of the Code Enforcement Officer together  
26 with attached Exhibits, evidencing the excessive outside storage of materials and accumulation of  
27 rubbish on THE PROPERTY as violations of Riverside County Ordinance ("RCO") Nos. 348 and  
28 541 and as a public nuisance.

1 **SUMMARY OF EVIDENCE**

2 1. Documents of record in the Riverside County Recorder's Office identify the owner  
3 of THE PROPERTY as Larry Richard Perryman ("OWNER").

4 2. Documents of title indicate that other parties may potentially hold a legal interest in  
5 THE PROPERTY, to wit: Rita A. Deam and Larry Richard Perryman, LLC, a Nevada Limited  
6 Liability Company ("INTERESTED PARTIES").

7 3. THE PROPERTY was inspected by Code Enforcement Officers on January 29, 2014  
8 and on six (6) subsequent follow up inspections, with the last being December 8, 2015.

9 4. During each inspection an accumulation of rubbish and excess outside storage was  
10 observed throughout THE PROPERTY consisting of but not limited to: wood, barrels, scrap metal,  
11 appliances, furniture, boxes and miscellaneous items, of about 2,000 square feet.

12 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance  
13 Nos. 348 and 541 by the Code Enforcement Officer.

14 6. On September 24, 2014, a Notice of Pendency of Administrative Proceedings was  
15 recorded at the Riverside County Recorder's Office as instrument number 2014-0361693 and on July  
16 30, 2015, as Instrument No. 2015-0340331.

17 7. On May 11, 2015, a Notice of Violation was posted on THE PROPERTY. On May 7,  
18 2015, a Notice of Violation was mailed to OWNER and INTERESTED PARTIES by certified mail,  
19 return receipt requested.

20 8. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance"  
21 providing notice of the public hearing before the Board of Supervisors was mailed to OWNER and  
22 INTERESTED PARTIES and was posted on THE PROPERTY.

23 **FINDINGS AND CONCLUSIONS**

24 WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in  
25 regular session assembled on December 15, 2015, finds and concludes that:

26 1. WHEREAS, the excessive outside storage of materials and accumulation of rubbish  
27 on the real property located at Parcel East of 68190 St. Moritz Drive, Pinyon Pines, Riverside  
28 County, California, also identified as Assessor's Parcel Number 635-262-015 violates RCO Nos. 348

1 and 541 and constitutes a public nuisance.

2 2. WHEREAS, the OWNER, occupants and any other person having possession or  
3 control of THE PROPERTY shall abate the accumulation of rubbish and excessive outside storage of  
4 materials by removing and disposing of all rubbish and excessive outside storage on THE  
5 PROPERTY in strict accordance with all Riverside County Ordinances, including but not limited to  
6 RCO Nos. 348 and 541 within ninety (90) days.

7 3. WHEREAS, the OWNER AND INTERESTED PARTIES ARE HEREBY  
8 FURTHER NOTICED that the time within which judicial review of the administrative  
9 determinations made herein must be sought is ninety (90) days from the posting and mailing of the  
10 Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by California Code of  
11 Civil Procedure Section 1094.6.

12 **ORDER TO ABATE NUISANCE**

13 IT IS ORDERED that the accumulation of rubbish and excessive outside storage of materials  
14 on THE PROPERTY be abated by OWNER or anyone having possession or control of THE  
15 PROPERTY by removing and disposing of all rubbish and excessive outside storage of materials on  
16 THE PROPERTY in strict accordance with all Riverside County Ordinances, including but not  
17 limited to RCO Nos. 348 and 541, within ninety (90) days of the posting and mailing of this Order to  
18 Abate Nuisance.


19 IT IS FURTHER ORDERED that if the accumulation of rubbish and excessive outside  
20 storage of materials is not removed and disposed of in strict accordance with all Riverside County  
21 Ordinances, including but not limited to RCO Nos. 348 and 541 within ninety (90) days of the date  
22 of this Order to Abate Nuisance, the accumulation of rubbish and excessive outside storage of  
23 materials may be abated and disposed of by representatives of the Riverside County Code  
24 Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's  
25 consent or a Court Order when necessary under applicable law.

26 IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity  
27 for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special  
28 assessment against THE PROPERTY pursuant to Government Code section 25845 and RCO Nos.


1 348, 541, and 725. Under RCO No. 725, "abatement costs" means "any costs or expenses  
2 reasonably related to the abatement of conditions which violate County Land Use Ordinances, and  
3 shall include, but not be limited to, enforcement, investigation, collection and administrative costs,  
4 attorneys fees, and the costs associated with the removal or correction of the violation." Reasonable  
5 abatement costs accrued by the Code Enforcement Department will be recoverable from OWNER  
6 even if THE PROPERTY is brought into compliance within ninety (90) days of the date of this  
7 Order to Abate Nuisance.

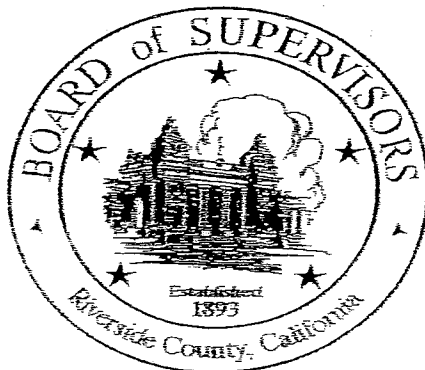

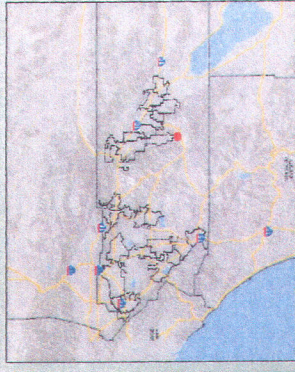
