BACKGROUND:

Summary

Recently, Emergency Services notified the County of Riverside Transportation Department that the spelling of a street name, on a street sign located in the El Cerrito area, did not match the legal spelling of the street name on public records. Residents of the street were queried by mail regarding their preference as to the street name; their preference was to leave the spelling on the street sign as it has been for over 30 years and correct public records. This action will formally correct the spelling in public record to match the street name sign of Sarsaparilla Drive.


