
RECOMMENDED MOTION: That the Board of Supervisors:



Summary (continued)

This event will specifically fund improvements at the YMCA Youth Center in Home Gardens and the YMCA Youth Center in Jurupa.
4. The donation to the Jurupa Area Recreation and Parks District will be used to sponsor the following events that will be put on by the District: Jurupa Valley Community 5K run, repairs to the Veteran's Wall, Veteran's Memorial Wall Ceremony, Independence Day Celebration, Spooktakular and Winter Carnival.
