

BACKGROUND:

Summary (continued)

1. The donation to The Affiliates of the University of California, Riverside (UCR) will be used to help fund scholarships for students that are motivated to complete college, despite financial hardships.
2. The donation to the Norco Horseweek Committee will be used to help fund Norco Horseweek, which is a series of community events like rodeos, chili cook offs, bingo, horseshoe tournament, obstacle course on horseback, and kids play day to name a few. All proceeds of this event will benefit the senior and pet foundations of Norco. Last year the committee donated over \$30,000.
3. The donation to the Martin Luther King High School Choir will be used to purchase a portable stage that will be used for show choir and other performing arts uses.
4. The donation to the Riverside Sunrise Rotary will be used to sponsor their annual fundraising event which raises funds for numerous non-profits throughout the Riverside community.
