BACKGROUND: Community Designation funds will be given to the following organizations:

1. Riverside County Black Chamber of Commerce—annual support will assist with services and operations that will increase economic conditions in the community such as business resources, educational programs and developmental skills.
2. Riverside Area Rape Crisis Center—annual donation will be used to support their services and operations to provide direct services to victims of sexual assault and their families. Education programs, prevention, awareness and self-defense programs are at no cost to the communities of the fifth district. Prevention presentations across the full spectrum of the population and will in addition assist law enforcement and the District Attorney's office by accompanying the victim through judicial proceedings.
3. Law Enforcement Appreciation Committee (LEAC)—annual donation will be utilized to support their program and operations for the annual Law Enforcement Appreciation Awards ceremony on April 28, 2016. Local law enforcement professionals will be honored for their exemplary service to their communities.
4. Perris Valley Chamber Commerce—annual support will be used to assist with services and operations, such as workshops, training and legislative updates to the local businesses which will benefit the economic conditions of the community.
