The Human Resources Department along with the advisory services of Ralph Andersen & Associates, Executive Search and Consulting firm conducted a nationwide recruitment search for the replacement of Jerry Wengerd, Behavioral Health Director and Public Guardian. After a thorough screening process of all applicants, including input from the Behavioral Health Commission, Steven Steinberg demonstrated the necessary requirements for the position of Behavioral Health Director in accordance with the California Code of Regulations, 9 CCR 620. Furthermore, Section 2.28.010 of the County Code provides that "the Mental Health Director of the County shall be ex officio the Public Guardian".

**Summary (continued)**

In June 1984 the Department of Mental Health and the Office of Public Guardian were consolidated and John Ryan served as Director of the combined department.

On April 19, 2005, Agenda Item 3.33, the Board appointed Jerry Wengerd as Mental Health Director and Public Guardian, effective May 12, 2005.

The official appointment date for Steven Steinberg as Behavioral Health Director and Public Guardian should be reflected as February 18, 2016.

Mr. Steinberg has been a dedicated employee of the County of Riverside for over 25 years and has most recently served in the position of Assistant Mental Health Director since June 2012.
