



**Summary**

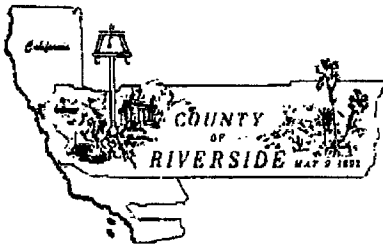


