

BACKGROUND:

Summary (continued)

1. The donation to the Riverside County Philharmonic will help fund the Adventures in Music Program that provides free music education to K12 students through school visits by Philharmonic Trios as well as sponsored tickets to performances at the Fox Performing Arts Theater. This donation will also help fund the "Heartstrings" program that partners with nonprofit organizations to make sponsored tickets available to frail and very low income seniors, and disabled children and adults.
2. The donation to Starting Over will help sponsor the 5th annual Back Pack and School Supply Giveaway Program where hundreds of backpacks with school supplies are given to low income children. Outreach is done through probation, fair housing, mental health and 211.
3. The donation to the Jurupa Valley Boxing Club will be used to help provide equipment for the club, and sponsor tournament fees for at risk youth.
4. The donation to Service through Action will help sponsor the Horse Town Brew N' Que Festival will helps unify the community and raise funds for local non-profits serving the Norco area.
