**RECOMMENDED MOTION (continued):**

3. If the owner or whoever has possession of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.

4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.

5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials on the real property is declared to be in violation of Riverside County Ordinance No. 348, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

**BACKGROUND:**

1. An inspection was made on the subject property by Code Enforcement Officer Brett Pollard on August 13, 2012. The Inspection revealed excess outside storage of materials on the subject property in violation of Riverside County Ordinances No. 348. The items included but were not limited to: three (3) flatbeds trailers and holiday decorations, of about 720 square feet.

2. There have been approximately eleven (11) subsequent follow up inspections, with the last inspection being on August 6, 2015. The property continues to be in violation of Riverside County Ordinance No. 348.

3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage.

**Impact on Citizens and Businesses**

Failure to abate will have a negative impact on citizens or businesses due to health and safety hazards, nuisance, and potential impact on real estate values.

10 I, Wayne Durant, declare that the facts set forth below are personally known to me except to  
11 the extent that certain information is based on information and belief which I believe to be true, and if  
12 called as a witness, I could and would competently testify thereof under oath:

13 1. I am currently employed by the Riverside County Code Enforcement Department as a  
14 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting  
15 property for violations and enforcement of the provisions of Riverside County Ordinances.

16 2. I am informed and believe and based thereon allege that on August 13, 2012, Officer  
17 Brett Pollard conducted an inspection of the real property described as 1 Parcel North of 35061 Barbara  
18 Lee Road, Mountain Center, Riverside County, California, and further described as Assessor's Parcel  
19 Number 568-094-003 (hereinafter described as "THE PROPERTY"). A true and correct copy of a  
20 Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and  
21 incorporated herein by reference as Exhibit "A."

22 3. A review of County records and documents disclosed that THE PROPERTY is owned by  
23 Trust Services of Cima (hereinafter referred to as "OWNER"). A certified copy of the County Equalized  
24 Assessment Roll for 2015-2016 tax year and a copy of the report generated from the County Geographic  
25 Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." The  
26 property is an unimproved parcel approximately 0.11 acres in size and is located within the R-1-2 1/2  
27 (One-Family Dwelling) zone classification. Since this is an unimproved parcel no outside storage is  
28 allowed.

1 4. Based on the Lot Book Reports from RZ Title Service dated April 17, 2013, and updated on June  
2 25, 2014, May 5, 2015 and July 2, 2015, it is determined that other parties may potentially hold a legal  
3 interest in THE PROPERTY, to wit: Randi Fjaeran (hereinafter referred to as "INTERESTED PARTY").  
4 True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by  
5 reference as Exhibit "C."

6 5. I am informed and believe and thereon allege that on August 13, 2012, Officer Pollard  
7 drove to THE PROPERTY to conduct an inspection from the road right of way. Officer Pollard observed  
8 excess outside storage on THE PROPERTY. The outside storage of materials consisted of, but was not  
9 limited to: three (3) flatbed trailers and holiday decorations, of about 720 square feet. This condition  
10 causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in  
11 Riverside County Ordinance ("RCO") No. 348.

12 6. On August 13, 2012, a Notice of Violation was posted on THE PROPERTY.

13 7. On August 14, 2012, a Notice of Violation was mailed to OWNER by first class mail.

14 8. On June 10, 2013, a Notice of Violation was mailed to OWNER and INTERESTED  
15 PARTY by first class mail, and was posted on THE PROPERTY on June 11, 2013.

16 9. On September 2, 2014, a Notice of Violation was mailed to OWNER and INTERESTED  
17 PARTY by certified mail, return receipt requested.

18 10. A site plan and photographs depicting the conditions of THE PROPERTY are attached  
19 hereto and incorporated herein by reference as Exhibit "D."

20 11. True and correct copies of each Notice issued in this matter and other supporting  
21 documentation are attached hereto and incorporated herein by reference as Exhibit "E."

22 12. There have been approximately eleven (11) subsequent follow up inspections, with the  
23 last inspection being August 6, 2015. Each inspection revealed the excessive outside storage remained  
24 on THE PROPERTY in violation of RCO No. 348.

25 13. Based upon my experience, knowledge and visual observations, it is my determination  
26 that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the  
27 general public.

28 ///

1 14. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO  
2 No. 348.

3 15. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the  
4 County Recorder, County of Riverside, State of California, on December 4, 2012, as Instrument Number  
5 2012-0586889. A true and correct copy of which is attached hereto and incorporated herein by reference  
6 as Exhibit "F."

7 16. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing  
8 notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER and  
9 INTERESTED PARTY by first class mail and was posted on THE PROPERTY. True and correct copies  
10 of the Notice, together with the Proof of Service, and the Affidavit of Posting of Notice are attached  
11 hereto and incorporated herein by reference as Exhibit "G."

12 17. The removal of all excess outside storage of materials currently on THE PROPERTY is  
13 required to bring THE PROPERTY into compliance with RCO No. 348, and the Health and Safety Code.

14 18. Accordingly, the following findings and conclusions are recommended:

15 (a) the excess outside storage of materials on THE PROPERTY to be deemed and  
16 declared a public nuisance; and

17 (b) the OWNER, or whoever has possession or control of THE PROPERTY, be  
18 required to remove all outside storage of materials on THE PROPERTY in strict accordance with the  
19 provisions of RCO No. 348.

20 (c) that if the materials are not removed and disposed of in strict accordance with all  
21 Riverside County Ordinances, including but not limited to RCO No. 348, within ninety (90) days of the  
22 date of the posting and mailing of the Board's Order to Abate Nuisance, the outside storage of materials  
23 may be abated and disposed of by representatives of the Riverside County Code Enforcement  
24 Department, a contractor, or the Sheriff's Department upon receipt of owner's consent or a Court Order  
25 when necessary under applicable law.
