BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the March 16, 2010 public auction sale. The deed conveying title to the purchasers at the auction was recorded April 26, 2010. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 3, 2010, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest. BACKGROUND: Summary (continued)

The Treasurer-Tax Collector has received two claims for excess proceeds:

- 1. Claim from the City of Palm Desert based on a Notice of Lien recorded October 20, 2005 as Instrument No. 2005-0868546 and a Notice of Lien recorded February 5, 2010 as Instrument No. 2010-0056504.
- Claim from Global Discoveries, Ltd., assignee for New Kennet Corporation based on an Assignment of Right to Collect Excess Proceeds dated April 11, 2011 and a Corporation Quitclaim Deed recorded May 24, 2000 as Instrument No. 2000-198480.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that the City of Palm Desert be awarded excess proceeds in the amount of \$1,240.00 and Global Discoveries, Ltd., assignee for New Kennet Corporation be awarded excess proceeds in the amount of \$43,731.13. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.




