



BACKGROUND:

Summary (continued)

1. The donation to Reach Out supports the Healthy Jurupa Program and more specifically, will sponsor "The Walk" which is a kick-off event to raise public awareness of the Jurupa Valley Waking Corridor and will engage community members in the many benefits of the corridor including family activities, access to resources, promotion of pedestrian and bike safety and highlighting local history.
