BACKGROUND:

Summary (continued)

The CAL FIRE law enforcement personnel are transitioning to a new model of the Sig Sauer handgun and all officers are required to change. This transition has begun and will replace all of the Fire Department's older models, to the new Sig Sauer P320. The new P320 will replace all primary and backup weapons and will be purchased by CAL FIRE. This will result in the surplus of thirty-seven (37) county owned weapons.

The Fire Department is requesting approval to sell the surplus handguns to CAL FIRE Law Enforcement Officers for \$375 each. All transactions will be completed by an authorized Federal Firearms License dealer and will remove any county responsibility for these weapons. Any cost associated with the transfer will be the Officers' responsibility. Allowing the purchase of the older model hand guns, by the officers who carry them, will lessen the financial impact to the county related to their disposal. The fair market value for these weapons, according to Sig Sauer, is \$375 per weapon. The total revenue is \$13,875. This revenue will be deposited into the General Fund and used for the Department's fire prevention needs. This will have no cost impact to the County General Fund.

Impact on Citizens and Businesses

There will be no impact on citizens and businesses.

Additional Fiscal Information

The Fire Department will receive \$13,875 of revenue in FY 15/16. This will have no cost impact to the County General Fund.
