**RECOMMENDED MOTION:** That the Board of Supervisors approve the attached, proposed Public Safety Enterprise Communication (PSEC) Internal Service Fund (ISF) rates for FY 2016/17, as recommended by the PSEC Steering Committee and the Riverside County Information Technology Department (RCIT).

**BACKGROUND:**

Summary

PSEC has been operating under a highly complex, tiered rate structure with over 1,900 rates, depending on numbers of talk groups and cell sites required for voice transmissions. For FY 2016/17, the rate structure was simplified to flat monthly rates for regular and emergency only use. In addition, the proposal includes 16 rates for engineering work, system installations, data, etc.
