On motion of Supervisor Ashley, seconded by Supervisor Benoit, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, April 5, 2016, be adjourned in memory of Joseph Medicine Crow, a 102-year-old Native American historian and last war chief of Montana's Crow Tribe who passed away on April 3, 2016.

A member of the Crow Tribe's Whistling Water clan, Medicine Crow was raised by his grandparents in a log house in a rural area of the Crow Reservation near Lodge Grass, Montana. His Crow name was "High Bird." Raised to be a warrior, his grandfather "Yellowtail" began his intense training at an early age. In 1939, Medicine Crow became the first of his tribe to receive Master's Degree in Anthropology. He served for decades as a Crow historian, cataloguing his people's nomadic history.

During World War II, Medicine Crow earned the title of "War Chief" after performing a series of daring deeds, including stealing horses from an enemy encampment and hand-to-hand combat with a German soldier whose life he ultimately spared. After returning from the European front, he was designated "Tribal Historian" by the Crow Tribal Council.

While embracing the changes that came with the settling on the West, Medicine Crow worked to bridge his people's cultural traditions with the opportunities of modern society. His voice became familiar to many outside the region as the narrator for the American Indian exhibits in museums across the country.

Medicine Crow was an instrumental force in both worlds, the White world and Indian world. For his efforts, he was awarded the Presidential Medal of Freedom in 2009 by President Obama. He was also nominated for the Congressional Gold Medal and was awarded Honorary Doctoral Degrees from USC and Montana's Rocky Mountain College.

Medicine Crow was a loving husband to his wife who preceded him in death in 2009 and a devoted family man and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
