Since its opening, TVH has made significant economic contributions to the community including the creation of over 670 new jobs and an upsurge in medical office development along the Temecula Parkway corridor. Each hospital job supports an average of two more jobs and every dollar spent by the hospital supports \$2.30 of business activity. The growth in medical office development along the Temecula Parkway has resulted in a 57% increase in rental fees, 146,524 square feet of new medical office space currently in development and a 9% increase in retail space rent as well as increases in the purchases of goods and services.

The Riverside County Workforce Development Board (WDB) has identified health care as a targeted industry for workforce development services and industry engagement. As such, the Board has actively sought local health care leaders to serve on the WDB and regional ad hoc committees. Ms. Wetton's, as CEO of TVH, is both a large-scale employer and an expert in healthcare workforce needs. Her appointment will further the WDB's efforts in the health care sector. Additionally, Ms. Wetton, through participation on the WDB, will have an opportunity to increase TVH's partnerships with businesses, community based organizations, and educational institutions. If approved, Ms. Wetton's two-year term will expire March 22, 2018.
