**BACKGROUND:  
Summary**

1. The Colorado River Fair Junior Livestock Auction was held on March 20, 2016. The Junior Livestock Auction supports the local 4-H Club and Future Farmers of America (FFA) youth in the Palo Verde Valley. CID funds will be used to support the 4-H Club and FFA programs in the Blythe area.
2. The Joslyn Center will hold the National Senior Health and Fitness Day on May 25, 2016. This health fair will be held in conjunction with the industry leaders in the areas of senior health and fitness. This health fair will provide vital information, activities and lectures for seniors in the Coachella Valley. CID funds will be used toward the cost of rental equipment such as tables and chairs.
3. The Indian Wells Rotary Club will hold their annual Student Scholarship Gala on May 1, 2016. This event will raise scholarship funds for students who are in their third and fourth year attending California State University, San Bernardino Palm Desert Campus. Qualifying students from the Coachella Valley will receive a \$1,000 scholarship to continue with higher education. CID funds will be used toward scholarships.
