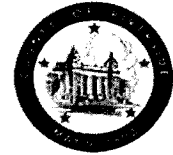

**BACKGROUND:**

**Summary**

Mental Health initiated and approved a project request for the Indio Milestones Mental Health Adult Residential facility located at 82-485 Miles Avenue in Indio, California. The project included the remodel of the on-site kitchen, dining room, laundry room, improvements to the electrical system and rehabilitation of the roof.

On July 17, 2012, the Board approved the construction agreement for Job Order Contract No. 004 between the County of Riverside and Angeles. Pursuant to the contract, a job order was issued for the improvements in the amount of \$322,162.

Angeles has completed the work and the Indio Milestones Mental Health Adult Residential Facility Improvement project has been inspected and found to comply with the contract requirements. The Economic Development Agency therefore recommends that the Clerk of the Board record the Notice of completion. This Board action will release the contract retention funds to Angeles in the amount of \$16,108 after the Notice of completion has been recorded and the 35 day lien period has expired per contract terms. The contract retention funds are within the overall project budget and no additional funding is required.

**Impact on Citizens and Businesses**

The Indio Milestones Mental Health Adult Residential Facility, which serves mentally ill adults, provides housing and on-site mental health services. The improvements to the facility better serve both the residents and the staff by improving the operational functionality of the building and upgrading the laundry, dining room and kitchen.
