BACKGROUND:

On March 1, 2016, the Board of Supervisors approved the conduct of election services for the City of Rancho Mirage. Election costs fully reimbursable from the City of Rancho Mirage are approximately \$84,000.

The election was held on April 12, 2016 with about 57.17% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the City of Rancho Mirage General Municipal Mail Ballot Election.

Impact on Citizens and Businesses

Registered voters who reside in the City of Rancho Mirage had the opportunity to elect two City Councilmembers and vote on four measures.

As approved by the Board of Supervisors on March 1, 2016, local jurisdictions will reimburse the Registrar of Voters for the full cost of conducting their election.

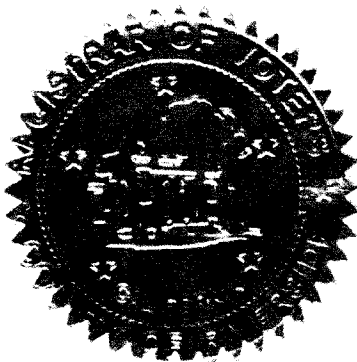
