BACKGROUND:

Summary

1. The Desert Recreation District will be providing summer activities in the eastern Coachella Valley. Many of the youth and families in this area are low-income and have few options for family recreation. The summer activities will include programs for elementary school students and teenage residents. CID funds will be used toward the cost of program supplies, snacks, craft supplies, marketing cost, and transportation to the DRD pools.
2. The Indio Rotary Math Field Day was held on May 14, 2016 at John Glenn Middle School in Indio. Three school districts in the Coachella Valley, and private schools, participated with more than 350 students competing for recognition for themselves and their schools. This event encourages students to study and enjoy math while motivating them to develop and apply their math skills. CID funds will be used to purchase awards for the winning students.
3. The Sky Valley Community Center building and grounds are for the benefit of the public and to serve the residents of the Sky Valley community. The community center is used for meetings of the community council, homeowners association and emergency team, and as the mobile library site. The CID funds will be used toward the cost of installing new light fixtures and a quick disconnect fixture to the power supply of the building's electric generator.
4. United Way of the Desert is sponsoring nine weekly walks and a workplace wellness program starting on August 20, 2016 and continuing through October 22, 2016. This is a no-cost community health program designed to encourage healthy habits and lifestyles for families and residents in the Coachella Valley. The weekly walks will take place in Desert Hot Springs, Cathedral City, Indio, Palm Springs, Coachella, La Quinta, Indian Wells, Rancho Mirage, and Palm Desert. In addition, United Way of the Desert is engaging business partners through a workplace wellness challenge to coincide with the nine weekly walks. The CID funds will be used toward marketing and supply expenses such as printing cost, water bottles, t-shirts, awards and photography.
