BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the March 20, 2012 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 11, 2012. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 6, 2012, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest. BACKGROUND: Summary (continued)

The Treasurer-Tax Collector has received two claims for excess proceeds:

- 1. Claim from MM Network Recovery Assets, agent for Anita Fellabaum based on an Authorization for Agent to Collect Excess Proceeds dated May 8, 2013, a Grant Deed recorded October 5, 2004 as Instrument No. 2004-0788608 and a Declaration of One and the Same Statement of Anita Fellabaum dated July 23, 2015.
- 2. Claim from Riverside County Code Enforcement Department based on a Notice of Noncompliance recorded March 3, 2008 as Instrument 2008-0102909, a Notice of Noncompliance recorded March 22, 2011 as Instrument 2011-0128231, and a Notice of Pendency of Administrative Proceedings recorded August 23, 2011 as Instrument No. 2011-0372494.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that MM Network Recovery Assets, agent for Anita Fellabaum Trustee be awarded excess proceeds in the amount of \$5,475.44. The claim from Riverside County Code Enforcement Department be denied since the claim has been paid in full. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.
