Born on July 25, 1925, Robert proudly served in the United States Army in the European Theater during World War II. After moving to Riverside in 1946, he enrolled at La Sierra College, graduating with a Bachelor's Degree in Chemistry in 1950. He taught in the La Sierra College Department of Chemistry from 1950 to 1952 and worked as a Research Chemist at the Mira Loma Quarter Master Depot from 1952 to 1955. He returned to the classroom in 1955 and for the next nine years taught chemistry at Pacific High School in San Bernardino.

Continuing his education, Robert earned a Master of Arts Degree in 1958 from California State University, Los Angeles and a Juris Doctorate Degree in 1964 from the University of Southern California. He then went into the General Practice of Law and began his civic service career, serving on the Governing Board, Alvord Unified School District from 1965 to 1971, Riverside City Council from 1971 to 1974, and was appointed to the Riverside Municipal Court Bench by Governor Ronald Reagan in 1974. He was elected to the Riverside County Superior Court in 1986 and served until his retirement in 1994, after which he continued to serve as a Bench Officer by appointment until 2012.
