**BACKGROUND:**

**Summary**

The County of Riverside (County) Transportation Improvement Program (TIP) provides for resurfacing of the North San Jacinto Group in the Soboba Hot Springs area. The following four roads are included:

| Road Name        | Begin             | End                  | Road Length (Ft) |
|------------------|-------------------|----------------------|------------------|
| Chabela Dr       | Soboba Rd.        | to San Jose Dr.      | 370              |
| San Jose Dr.     | Chabela Dr.       | to E'ly San Jose Dr. | 1922             |
| Granite View Dr. | W'ly San Jose Dr. | to E'ly San Jose Dr. | 1082             |
| Las Palmas Ct.   | San Jose Dr.      | to S'ly End          | 270              |

The roads have moderate damage with alligator cracking and some block cracking, generally associated with age and thermal effects, and are in need of repair. The purpose of this project is to resurface these roads to provide the public with a smooth paved roadway that will improve the safety for vehicular traffic.

Additional work includes the replacement of AC dike, localized concrete curb and gutter work, replacement of pavement markings and raised pavement markers, and other work as required.

CEQA Guidelines Section 15301(c) describes the minor alteration of existing public facilities with negligible or no expansion of an existing use as a categorical exemption under CEQA; the project qualifies under this exemption since it is a maintenance activity taking place on existing County roads and there is no expansion of use.

The submitted plans and specifications have been approved as to form by County Counsel

**Impact on Residents and Businesses**

The proposed improvements will benefit the project area by significantly improving the service life of the existing infrastructure.

The work is scheduled to begin in Summer 2016. The roads will remain open during construction and will take approximately two months to complete.

The construction contract is estimated to cost approximately \$174,800. Construction is expected to finish in FY 2016/2017 and is funded with Gas Tax/HUTA. There are no General Funds used in this project.

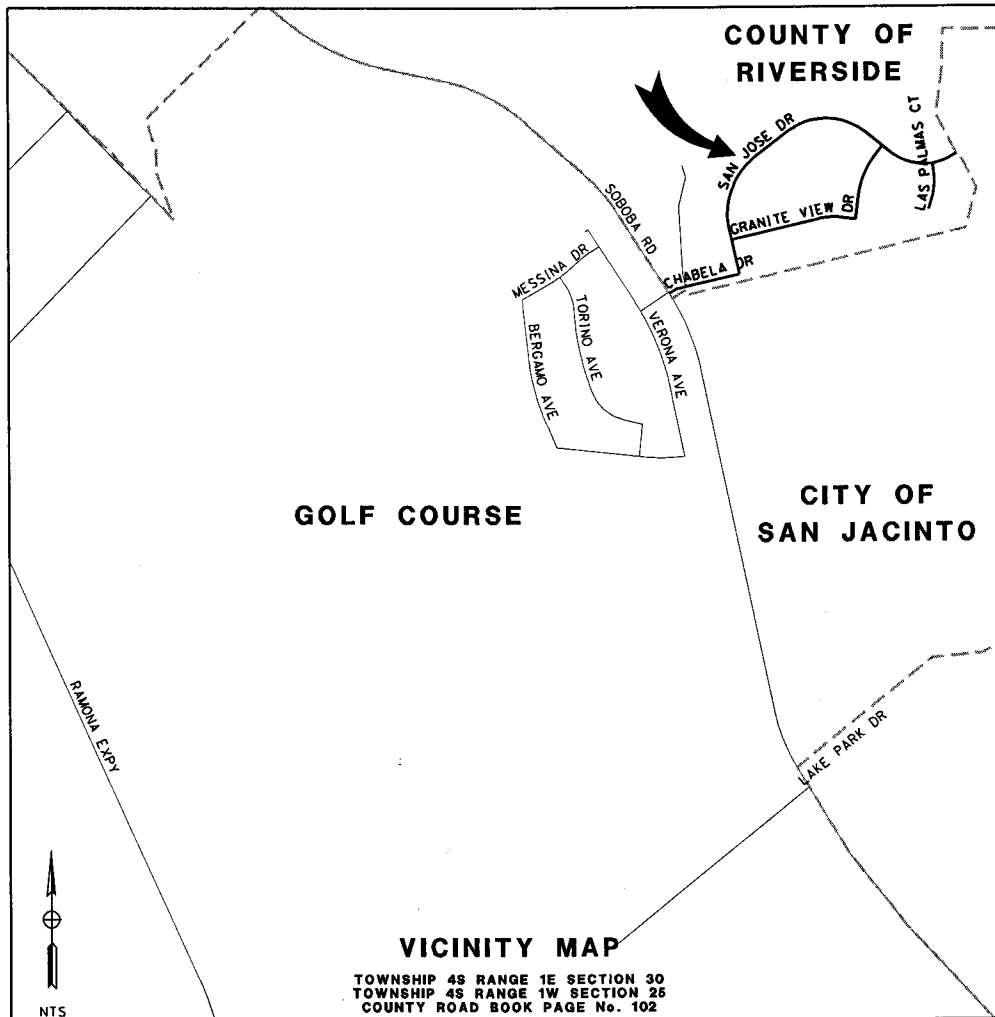
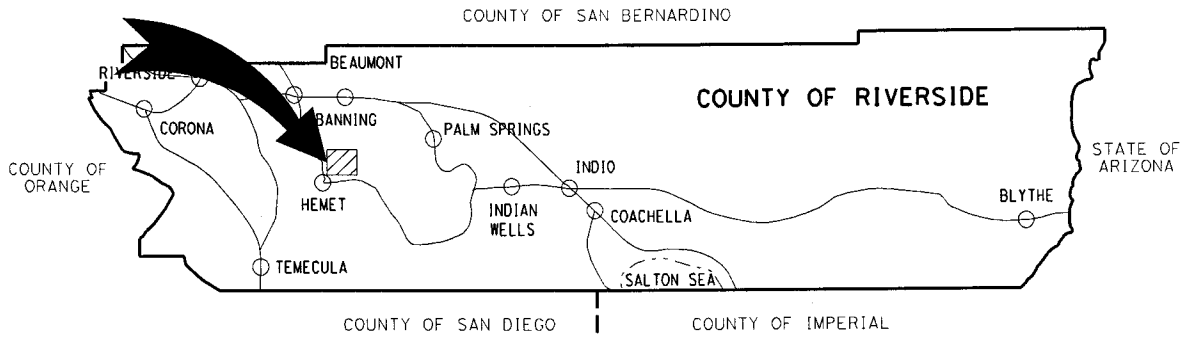
Vicinity Map

COMMUNITIES OF SOBOBA HOT SPRINGS

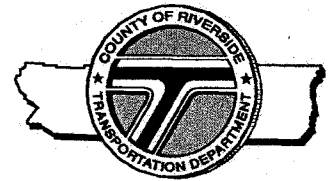

**PROJECT LOCATION:** Located in Western Riverside County, Valle Vista Community

**SUPERVISORIAL DISTRICT:** Third

**PROJECT DESCRIPTION:** The Riverside County Transportation Department (RCTD) proposes to rehabilitate 0.7 miles of local roads north of the City of San Jacinto and to the west of Soboba Road. The roads selected for rehabilitation include:

- Chabela Drive
- Granite View Drive
- San Jose Drive
- Las Palmas Court

As part of rehabilitation work, the project proposes to overlay the existing pavement; re-apply pavement markings, striping, and reflectors; adjust utilities to grade; and remove 35 feet of broken segments and reconstruct the pavement.

No additional right-of-way or temporary construction easements will be required. The project involves no streambed related activities and will improve public safety. All improvements will be performed on the same footprint as the existing roads mentioned above.

In accordance with Section 7.3.4 of the Western Riverside County MSHCP, necessary operation and maintenance activities conducted for safety purposes along existing roadways are considered a covered activity. Since the proposed rehabilitation of the above mentioned local roads are not within Criteria Cells or Public/Quasi Public Lands, they are exempt from survey and mitigation requirements.

The Riverside County Transportation Department Staff conducted a review of the above referenced project and has determined that the proposal qualifies for a Categorical Exemption per the California Environmental Quality Act (CEQA) Guidelines.

**The Riverside County Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:**

#### California Environmental Quality Act Guidelines:

**Section 15301 (c) – Existing Facilities** – There will be negligible or no expansion of

existing use since the road rehabilitation improvements will take place within the existing right-of-way. Existing streets are exempt from CEQA under Section 15301 (c).

Each bid shall be in accordance with plans, specifications and other contract documents, dated **April 2016**, and prepared by County of Riverside, whose address is same as the above, from whom they may be obtained upon deposit of **\$20.00** per set with 24" x 36" plans, plus mailing costs. No refund. Prospective bidders may preview the plans, specifications and other contract documents at no charge prior to purchase at the above noted location.

Pursuant to Labor Code section 1771.1, any Contractor bidding, or subcontractor to be listed on a bid proposal subject to Public Contract Code section 4104, shall not be qualified to bid after March 1, 2015, unless currently registered and qualified to perform public works pursuant to Labor Code section 1725.5. No Contractor or subcontractor may be awarded a contract or perform work on any contract for public work, after April 1, 2015, without proof of current registration with the Department of Industrial Relations pursuant to Labor Code section 1725.5 to perform public works.
