**BACKGROUND:**

**Summary**

On March 29, 2016 (Item 3-21), the Board of Supervisors approved the Pre-Qualification Package for the purpose of establishing a list of pre-qualified structured cabling contractors. On behalf of the Riverside County Information Technology Department, the Economic Development Agency advertised the Request for Qualifications on March 30, 2016 and received five responses. The applicants were evaluated based on technical ability, certifications and project experience in systems installations, resulting in the final recommended list of structured cabling contractors in Attachment A.

**Impact on Citizens and Businesses**

The pre-qualified list of structured cabling contractors will help expedite work on County projects by hiring contractors who have demonstrated experience in this trade.
