RECOMMENDED MOTION: That the Board of Supervisors grant approval to the Director of Transportation and Land Management, or his designee, to conduct force account work in the Woodcrest area, Mead Valley area, Good Hope area and Homeland area utilizing the County of Riverside Transportation Department (Transportation Department) day labor construction crews as set forth in Attachment A-1 hereto.

BACKGROUND:

Summary

The Transportation Department is planning on paving or reconstructing several county roads in the Woodcrest, Mead Valley, Good Hope, and Homeland areas using day labor construction crews. This work can be efficiently and cost effectively completed using Transportation Department crews, compared to the traditional bidding process. It should be noted that the Transportation Department contracts out the vast majority of its construction work to private contractors (over 90% last year).

Summary (continued)

Certain projects that are less complex and of a maintenance nature can be more efficiently and quickly accomplished using our road crews, due to the time and cost savings realized through not having to generate engineered plans and contract specifications, surveying, and inspection costs.

Assembly Bill 720 (AB720) sets forth modified requirements by which new road construction and road reconstruction can be performed by employees of a public agency. Under AB720, an agency may elect to utilize public employees to perform force account work, provided this work does not exceed 30% of the total value of all work performed by force account other than maintenance, as reported in the State Controller's Streets and Roads Annual Report as of January 1 of each year. The intent to use this authority must be declared prior to commencing the work.

The proposed projects with their associated construction budgets are listed in Attachment A-1. The total cost of the work is \$2,957,000.

Impact on Residents and Businesses

The proposed projects will reduce dust and improve access to local residents.

SUPPLEMENTAL:

Additional Fiscal Information

The Woodcrest area paving will be funded by Gas Tax funds (\$762,000).

The Mead Valley area paving will be funded by Gas Tax funds (\$379,000).

The Good Hope area paving will be funded by Gas Tax funds (\$500,000).

The Homeland area paving will be funded by Gas Tax funds (\$1,316,000).

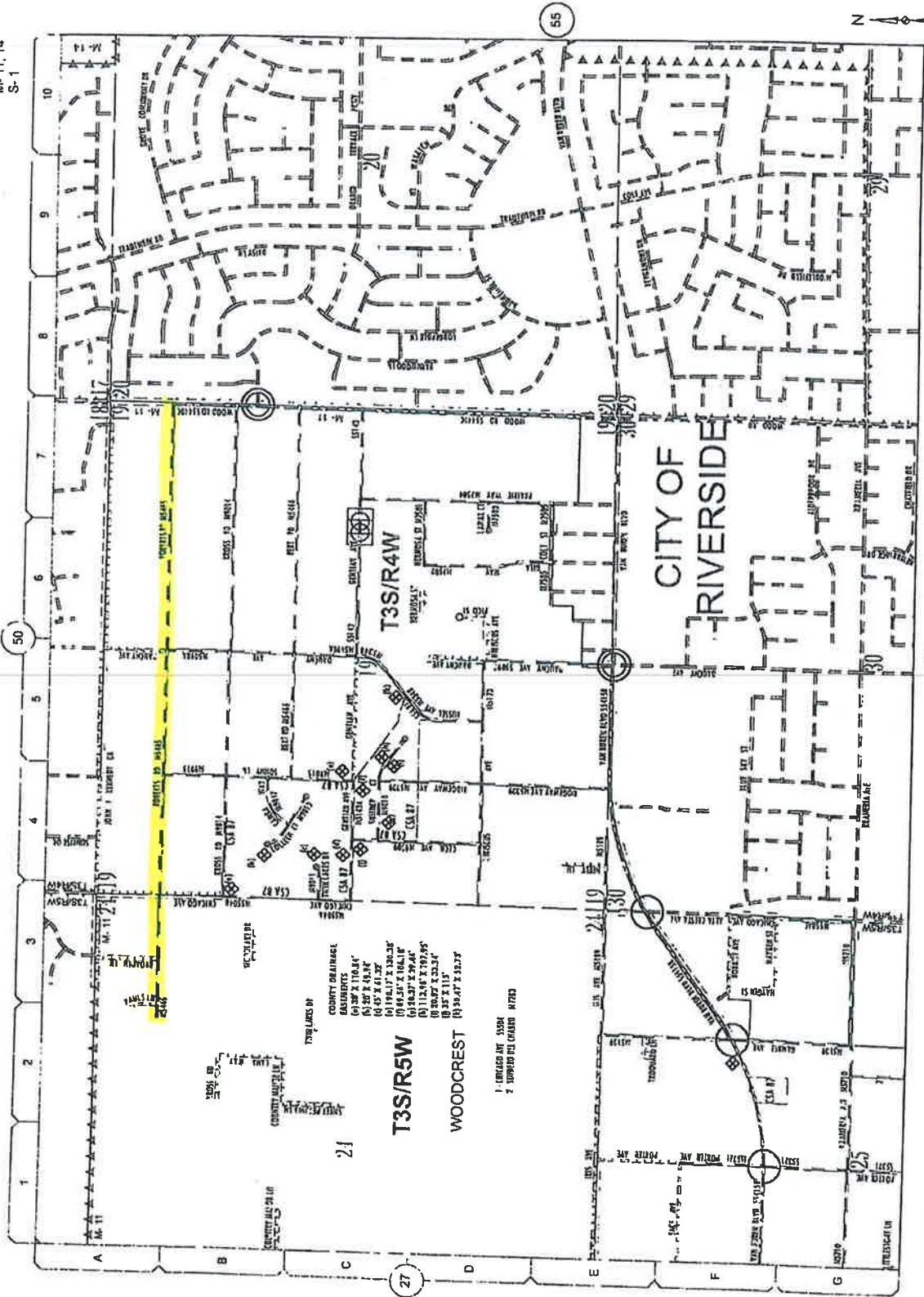

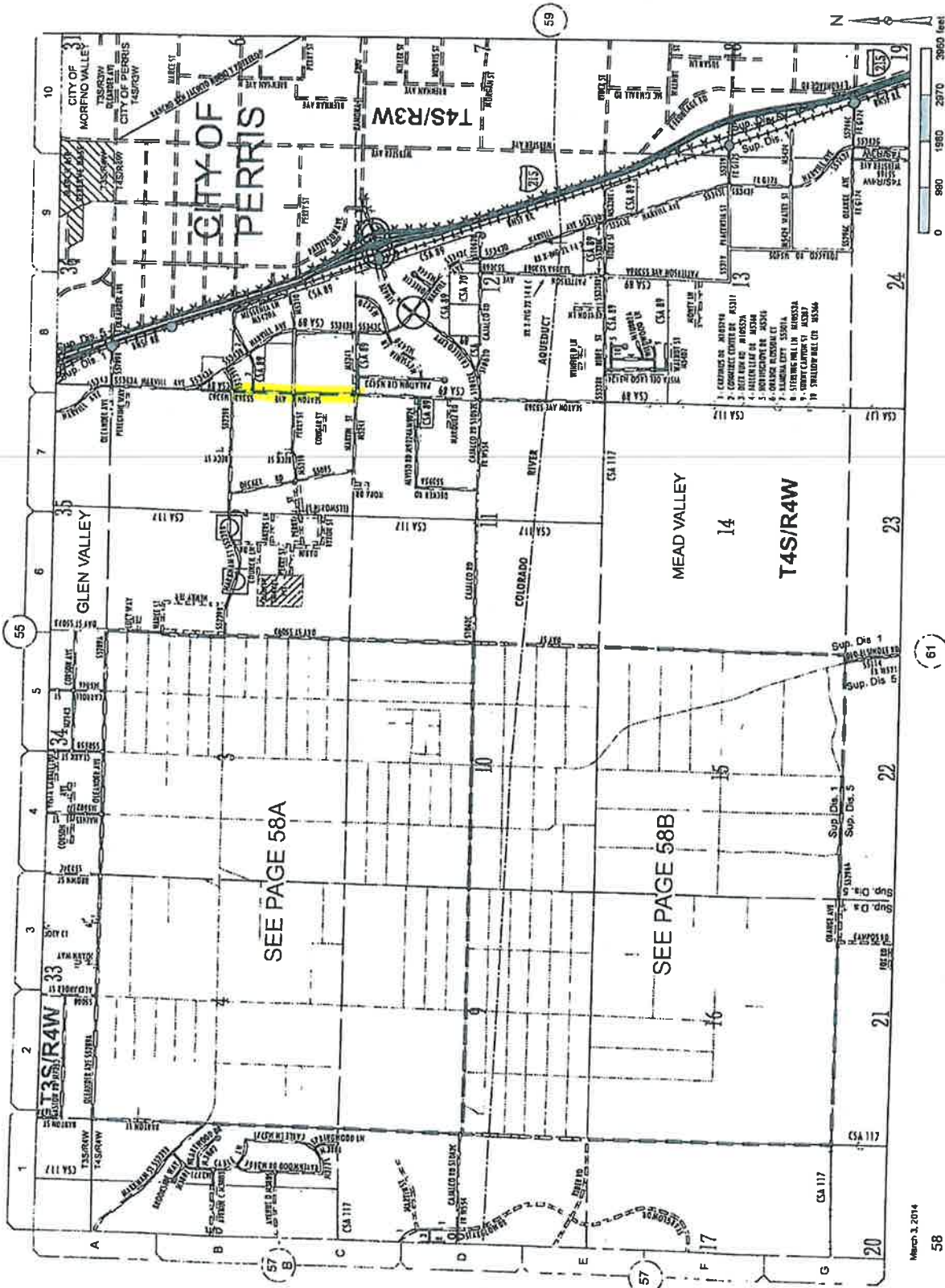

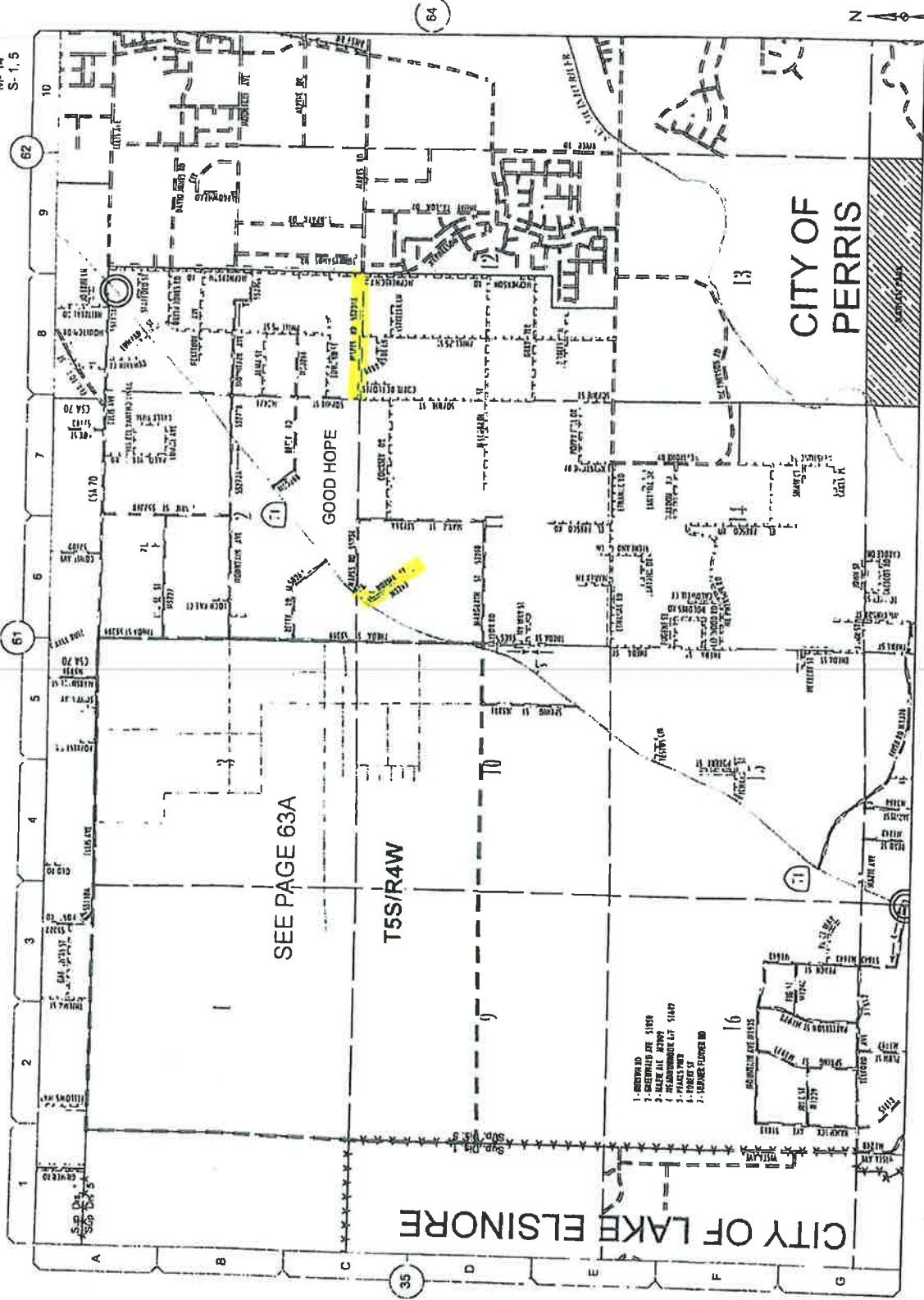
Vicinity Maps

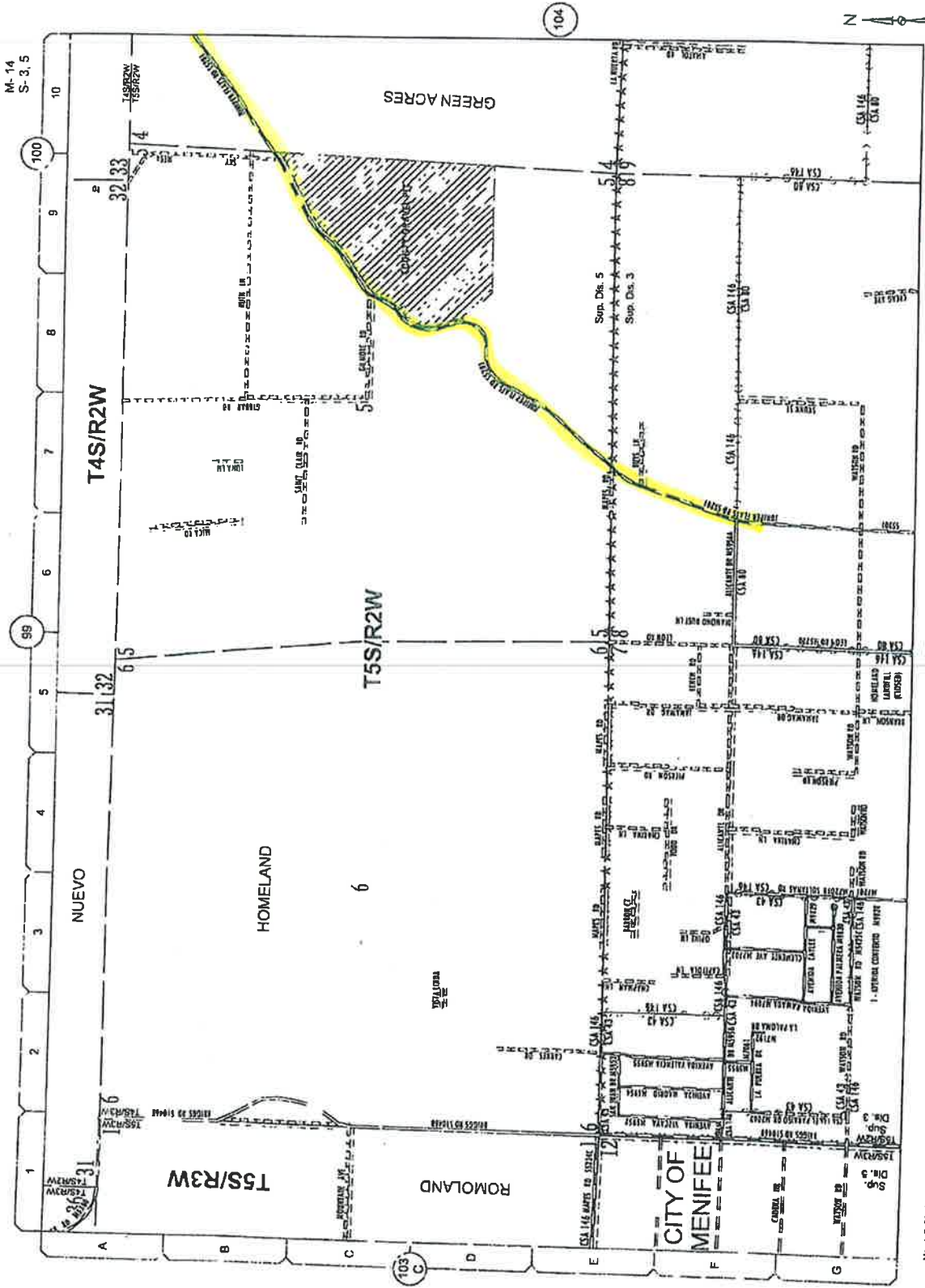

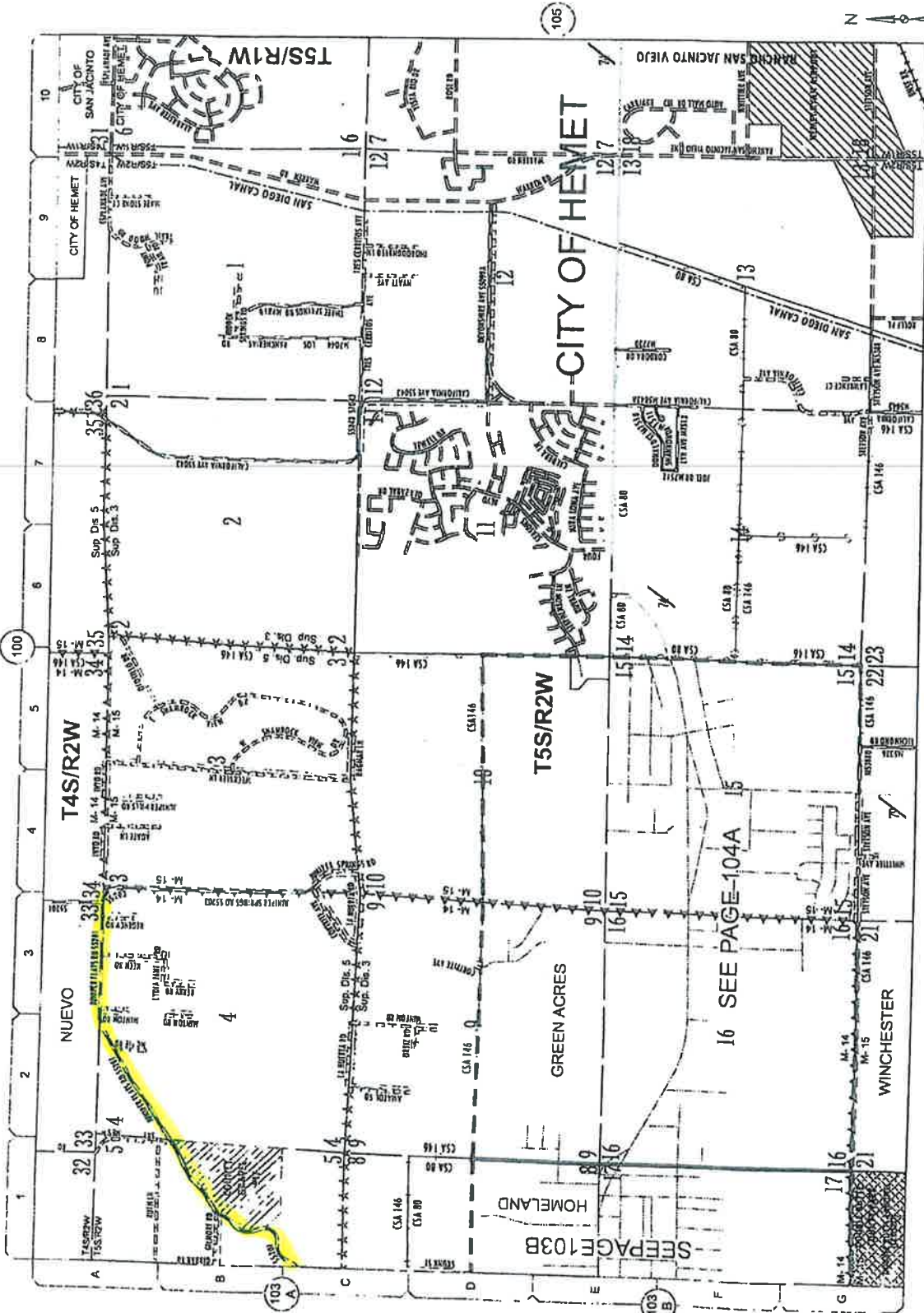
