1. The excessive outside storage of materials and accumulation of rubbish on the real property described as 24480 Juniper Springs Road, Homeland, Riverside County, California, APN: 455-060-004 be declared a public nuisance and a violation of Riverside County Ordinance Nos. 348 and 541.
2. David A. Carney, the owner of the subject real property, be directed to abate all accumulated rubbish and to limit outside storage of materials to two hundred (200) square feet with a maximum height of three (3) feet on the property by removing the same from the real property within ninety (90) days.

RECOMMENDED MOTION (continued):

3. If the owner or whoever has possession of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.

4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.

5. County Counsel be directed to prepare the necessary Findings of Fact, Conclusions and Order to Abate Nuisance for approval by the Board that the excess outside storage of materials and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 348 and 541, and a public nuisance.

BACKGROUND:

1. An inspection was made on the subject property by Code Enforcement Officer Lane Padilla on January 13, 2015. The inspection revealed excessive outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinance Nos. 348 and 541. The items included but were not limited to: hundreds of pallets, scrap metal, green waste, and heavy equipment, of about 6,775 square feet.

2. There have been approximately seven (7) subsequent follow up inspections, with the last inspection occurring on April 12, 2016. The property continues to be in violation of Riverside County Ordinance Nos. 348 and 541.

3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage and accumulated rubbish.

Impact on Citizens and Businesses

Failure to abate will have a negative impact on citizens or businesses due to health and safety hazards, nuisance, and potential impact on real estate values.

10 I, Lane e Padilla, declare that the facts set forth below are personally known to me except to
11 the extent that certain information is based on information and belief which I believe to be true, and if
12 called as a witness, I could and would competently testify thereof under oath:

13 1. I am currently employed by the Riverside County Code Enforcement Department as a
14 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting
15 property for violations and enforcement of the provisions of Riverside County Ordinances.

16 2. On January 13, 2015, I conducted an inspection of the real property described as 24480
17 Juniper Springs Road, Homeland, Riverside County, California and further described as Assessor's
18 Parcel Number 455-060-004 (hereinafter described as "THE PROPERTY"). A true and correct copy of a
19 Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and
20 incorporated herein by reference as Exhibit "A."

21 3. A review of County records and documents disclosed that THE PROPERTY is owned by
22 David A. Carney (hereinafter referred to as "OWNER"). A certified copy of the County Equalized
23 Assessment Roll for 2015-2016 tax year and a copy of the report generated from the County Geographic
24 Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." The
25 property is an improved parcel approximately 1.82 acres in size and is located within the R-A-5
26 (Residential Agricultural) zone classification. The zone allows for outside storage of materials on
27 improved parcels of one acre or more provided the amount is limited to two hundred (200) square feet
28 with a maximum height of three (3) feet. Accumulated rubbish is not permitted on any property within the
County of Riverside.

///

1 4. Based on the Lot Book Report from RZ Title Service dated April 21, 2015, and updated on
2 February 8, 2016, it is determined that other parties may potentially hold a legal interest in THE
3 PROPERTY, to wit: Sheila C. Buchan and Eastern Municipal Water District (hereinafter referred to as
4 "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto and
5 incorporated herein by reference as Exhibit "C."

6 5. On January 13, 2015, I arrived at THE PROPERTY to conduct an inspection. From the
7 road right of way, I observed excess outside storage and accumulated rubbish on THE PROPERTY. The
8 outside storage of materials and accumulated rubbish consisted of, but was not limited to: hundreds of
9 pallets, scrap metal, green waste, and heavy equipment of about 6,775 square feet. This condition
10 causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in
11 Riverside County Ordinance ("RCO") Nos. 348 and 541.

12 6. On January 13, 2015, a Notice of Violation was posted on THE PROPERTY.

13 7. On January 15, 2015, a Notice of Violation was mailed to OWNER by first class mail and
14 by certified mail, return receipt requested.

15 8. On July 22, 2015, Notice of Violation was mailed to OWNER and INTERESTED PARTY
16 Sheila C. Buchan, by certified mail, return receipt requested.

17 9. On March 3, 2016, Notice of Violation was mailed to INTERESTED PARTY Eastern
18 Municipal Water District, by certified mail, return receipt requested.

19 10. A site plan and photographs depicting the conditions of THE PROPERTY are attached
20 hereto and incorporated herein by reference as Exhibit "D."

21 11. True and correct copies of each Notice issued in this matter and other supporting
22 documentation are attached hereto and incorporated herein by reference as Exhibit "E."

23 12. There have been approximately seven (7) subsequent follow up inspections, with the last
24 inspection being April 12, 2016. Each inspection revealed the accumulated rubbish and excess outside
25 storage of materials remained on THE PROPERTY in violation of RCO Nos. 348 and 541.

26 13. Based upon my experience, knowledge and visual observations, it is my determination
27 that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the
28 general public.

1 14. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO
2 Nos. 348 and 541.

3 15. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the
4 County Recorder, County of Riverside, State of California, on July 30, 2015, as Instrument Number
5 2015-0339573. A true and correct copy of which is attached hereto and incorporated herein by reference
6 as Exhibit "F."

7 16. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing
8 notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER and
9 INTERESTED PARTIES by first class mail and was posted on THE PROPERTY. True and correct
10 copies of the Notice, together with the Proof of Service, and the Affidavit of Posting of Notice are
11 attached hereto and incorporated herein by reference as Exhibit "G."

12 17. The removal of all accumulated rubbish and excess outside storage of materials currently
13 on THE PROPERTY in excess of two hundred (200) square feet which shall be at a maximum height of
14 three (3) feet is required to bring THE PROPERTY into compliance with RCO Nos. 348 and 541, and the
15 Health and Safety Code.

16 18. Accordingly, the following findings and conclusions are recommended:

17 (a) the excessive outside storage of materials and accumulated rubbish on THE
18 PROPERTY to be deemed and declared a public nuisance; and

19 (b) the OWNER, or whoever has possession or control of THE PROPERTY, be
20 required to remove all outside storage of material in excess of 200 square feet and greater than 3 feet in
21 height and all accumulated rubbish on THE PROPERTY in strict accordance with the provisions of RCO
22 Nos. 348 and 541.

23 (c) that if the materials and rubbish are not removed and disposed of in strict
24 accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541,
25 within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, the
26 outside storage of materials and accumulated rubbish may be abated and disposed of by representatives
27 of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon
28 receipt of owner's consent or a Court Order when necessary under applicable law.

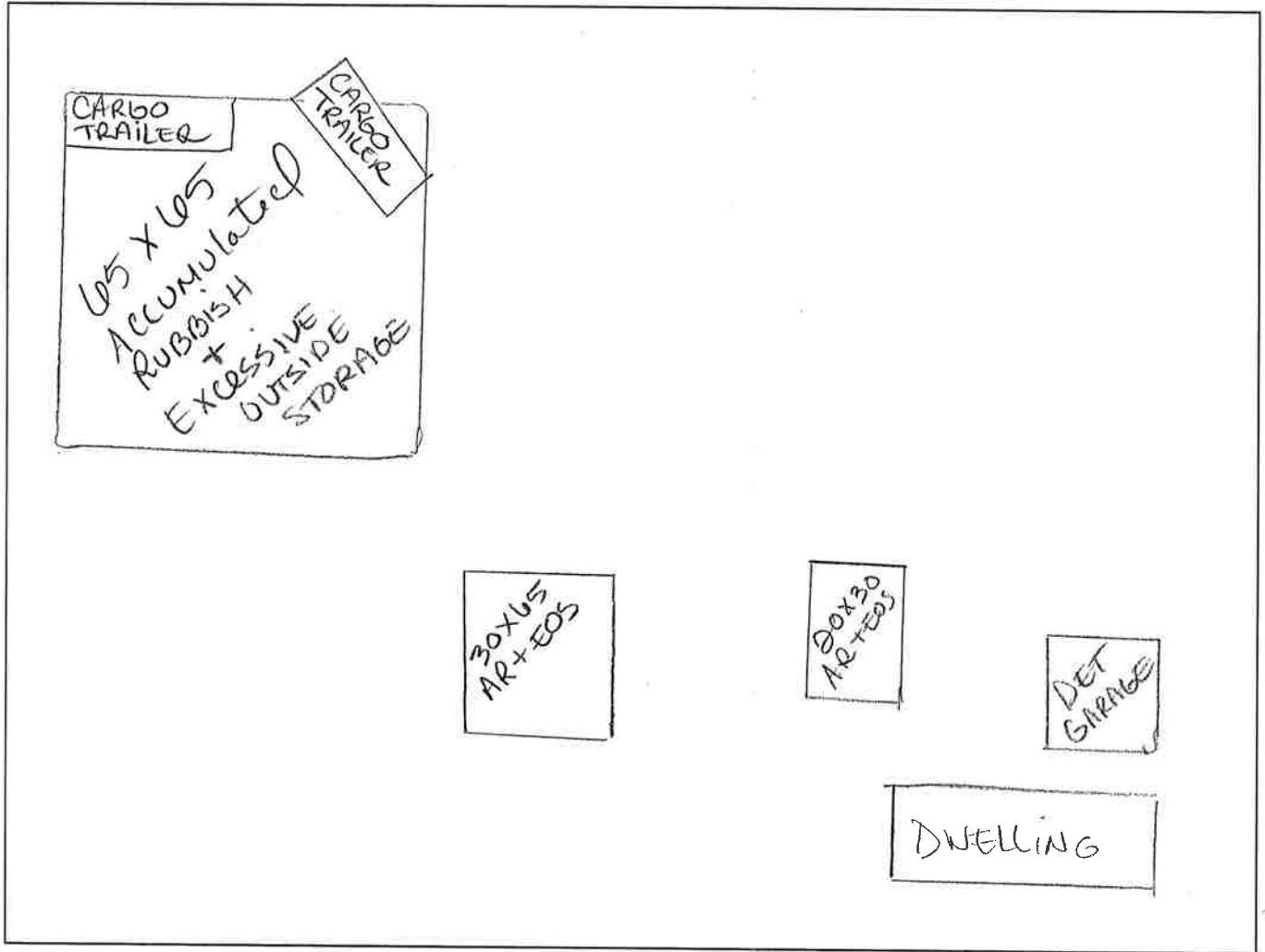
