Summary

The Economic Development Agency (EDA) issued a Request for Qualifications (RFQ) for OSHPD IOR firms on January 3, 2016 in accordance with Board Policy H-7. Of the 15 firms that responded to the RFQ, two were deemed non-responsive, thirteen were evaluated, and nine were deemed to be pre-qualified. This list will enable EDA to quickly respond to client needs and accelerate delivery of active capital projects. EDA will conduct the required annual performance reviews on these firms as required.
