**BACKGROUND:**

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the February 4, 2013 public auction sale. The deed conveying title to the purchasers at the auction was recorded April 1, 2013. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on April 24, 2013, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

**BACKGROUND:**

**Summary (continued)**

The Treasurer-Tax Collector has received four claims for excess proceeds:

1. Claim from Found Extra Money, LLC, assignee for Liston Brick Company of Corona based on an Assignment of Right to Collect Excess Proceeds dated March 28, 2014 and a Quitclaim Deed recorded March 6, 2000 as Instrument No. 2000-081066.
2. Claim from the State of California, State Board of Equalization based on a Notice of State Tax Lien recorded March 31, 2011 as Instrument No. 2011-0141088.
3. Claim from the People of the State of California ex rel. South Coast Air Quality Management District based on an Abstract of Judgment recorded March 9, 2007 as Instrument No. 2007-0164423.
4. Claim from the United States Environmental Protection Agency based on a Final Order CAA Appeal No. 07-03 recorded September 3, 2008 as Instrument No. 2008-0483949.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Found Extra Money, LLC, assignee for Liston Brick Company of Corona be awarded excess proceeds in the amount of \$23,109.71. The claim from the State of California, State Board of Equalization be denied since the lien has been satisfied. The claim from the People of the State of California ex rel. South Coast Air Quality Management District be denied since the lien has been satisfied. The claim from the United States Environmental Protection Agency was withdrawn on September 3, 2015. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

In accordance with our previous conversation, I am amending the amount of the claim form dated May 1, 2013 for Recorder's Document No. 2008-0483949 recorded on September 3, 2008, from \$151,286.71 to \$173,345.69. All other information on the claim form attached is accurate and is attached hereto.

You have asked me to provide an explanation of why the change is being made. The following is the basis for changing the amount claimed, which was incorrect on the initial form. There are three components to the calculation of the debt owed: the interest, the administrative costs of collecting the debt and the penalty interest. In this case the interest is based on the current Treasury Value of Funds Rate for March 18, 2008, the date of the Final Order in the Liston matter. See the following link for interest rate: <http://fms.treas.gov/cvfr/index.html>. See 40 CFR section 13.11(a)(1) for legal basis to collect interest. The 5% annual, fixed, simple (non compounding) interest rate charged on a monthly basis begins to accrue 30 days after the date of the Final Order. Id. The administrative cost is assessed at \$15 per month. See 40 CFR section 13.11(b). The penalty interest is calculated by the computer model at 6% annual, fixed, simple (non compounding) interest rate charged on a monthly basis. See 40 CFR section 13.11(c).

The total penalty based on the EPA computer model is \$173,345.69. The attached certification by EPA employee, Blake Edwards, provides a breakdown for the dollar amount for each component of the total penalty identified above. This is the corrected amount that is due so that the lien can be released.

For your convenience, I am also forwarding the documents originally submitted. I have copied the attorney for Mr. Liston and the representative of the title company in order for them to be able to expeditiously resolve this matter related to the sale of the property.

On appeal, Liston argues that the ALJ erred in concluding that Liston's net worth exceeded one million dollars. Appeal at 2. According to Liston, the evidence in the record does not support this conclusion and, as a result, Liston argues that the penalty should be reduced from \$116,402 to 107,504.64. *Id.* at 11. In response, U.S. EPA Region 9 (the "Region"), the complainant in this matter, states that it "does not oppose [Liston's] prayer for relief of a penalty amount of \$107,504.64 in order to expeditiously resolve this litigation." Non-Opposition to Appeal of the Initial Decision of the Presiding Officer at 2 (Feb. 28, 2008) ("Non-Opposition"). The Region requests that this Board issue a final order requiring Liston to pay a civil penalty of \$107,504.64. *Id.*

In a response filed on March 13, 2008, Liston states that "it concurs with the Region's Non-Opposition" and that "[t]he parties are in agreement regarding the amount of the penalty and seek a final order." Respondent's Response to Region's Non-Opposition (Mar. 13, 2008) ("Response"). In conjunction with its Response, Liston has filed a motion to withdraw its appeal. Respondent's Motion to Withdraw Appeal (Mar. 13, 2008) ("Motion").

Under these circumstances, Liston's motion is granted. Liston's appeal before this Board is hereby dismissed with prejudice. Further, the penalty assessed in the Initial Decision is modified as follows. Liston shall pay a civil penalty in the amount of \$107,504.64 within thirty (30) days of receipt of this Final Order. 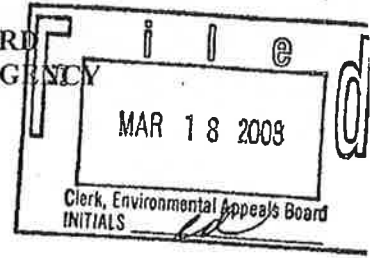

**FINAL ORDER**

On January 16, 2008, Liston Brick Company ("Liston") filed a notice of appeal from an Initial Decision issued by Administrative Law Judge Barbara A. Gunning ("ALJ"), along with a motion seeking a thirty-day extension of time to file an appellate brief. "Notice of Appeal [Concurrently Filed With Motion for Extension of Time to File Appellant Brief]." The Initial Decision found Liston liable for two violations of 40 C.F.R. part 63, subpart RRR (National Emission Standards for Hazardous Air Pollutants for Secondary Aluminum Production) and section 112 of the Clean Air Act, 42 U.S.C. § 7412. In addition, the ALJ found Liston liable for two violations of Section 114 of the Clean Air Act, 42 U.S.C. § 7414, for failing to comply with requests for information. For these violations the ALJ assessed a civil administrative penalty of \$116,402. By order dated January 18, 2008, the Board granted Liston's motion for an extension of time to file its appellate brief. *See* Order Extending Time to File Appellate Brief (Jan. 18, 2008). Liston filed its appellate brief on February 19, 2008. *See* Respondent's Appeal of the Initial Decision of the Presiding Officer (Feb. 19, 2008) ("Appeal").
