BACKGROUND:

Summary

The Treasurer-Tax Collector has received three claims for excess proceeds:

- 1. Claim from Rio Vista Village Associates, LLC based on a Grant Deed recorded June 14, 2005 as Instrument No. 2005-0470938.
- 2. Claim from Tri-State Land Surveyors and Civil Engineers, Inc. based on a Claim of Lien recorded October 24, 2007 as Instrument No. 2007-0653611 and Release of Mechanic's Lien recorded April 3, 2009 as Instrument No. 2009-0163604.
- 3. Claim from Priority Collections, Inc. based on an Abstract of Judgment recorded October 1, 2010 as Instrument No. 2010-0472489.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Rio Vista Village Associates, LLC be awarded excess proceeds in the amount of \$26,280.99. The claim from Tri-State Land Surveyors and Civil Engineers, Inc. be denied since the lien filed was released with Instrument No. 2009-0163604, recorded April 3, 2009. The claim from Priority Collections, Inc. be denied due to the claim being received after the June 22, 2015 deadline. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.


