RECOMMENDED MOTION: That the Board of Directors:

- 1. Approve and adopt Resolution No. 2016-04, which establishes the Riverside County Regional Park and Open-Space District's Fiscal Year 2016-2017 Appropriations Limit; and
- 2. Instruct the Clerk of the Board to return one (1) copy to the Riverside County Regional Park and Open-Space District.

BACKGROUND:

Summary

On November 6, 1990, a majority of voters in Riverside County voted to form the Riverside County Regional Park and Open-Space District (District). In that same measure, pursuant to Article XIII B of the California Constitution, the District's appropriations limit was set at \$25,000,000. Section 7910 of the Government Code requires that each year the governing body of each local jurisdiction adopt a resolution to establish its appropriations limit for the following fiscal year.

RESOLUTION NO. 2016-04

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE RIVERSIDE COUNTY
REGIONAL PARK AND OPEN-SPACE DISTRICT ESTABLISHING THE APPROPRIATIONS
LIMIT FOR FISCAL YEAR 2016-2017 FOR THE RIVERSIDE COUNTY REGIONAL PARK
AND OPEN-SPACE DISTRICT IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 9
OF TITLE 1 OF THE CALIFORNIA GOVERNMENT CODE

WHEREAS, Article XIII B of the Constitution of the State of California as proposed by the Initiative Measure approved by the people at the special statewide election held on November 6, 1979 and amended in June 1990 by the people of the State of California (Proposition 111), provides that the total annual appropriations subject to limitations of each local government shall not exceed the appropriations limit of such entity for the prior year adjusted for changes in the cost of living and population except as otherwise specifically provided for in said Article; and

WHEREAS, the State Legislature added Division 9 (commencing with Section 7900) to Title 1 of the Government Code of the State of California to implement Article XIII B of the Constitution; and

WHEREAS, Section 7910 of the Government Code provides that each year the governing body of each local jurisdiction shall, by resolution, establish its appropriations limit for the following fiscal year pursuant to Article XIII B at a regularly scheduled meeting or a noticed special meeting and that fifteen days prior to such meeting, documentation used in the determination of the appropriations limit shall be available to the public; and

WHEREAS, Proposition 111 as approved by the voters of the State of California, requires a recorded vote of the Board of Directors regarding which of the annual adjustment factors have been selected each year; and

WHEREAS, Section 7902(b) of the Government Code sets forth the method for determining the appropriations limit for each local jurisdiction for the 2016-2017 fiscal year; and

WHEREAS, the Board of Directors of the RIVERSIDE COUNTY REGIONAL PARK AND

OPEN-SPACE DISTRICT wishes to establish the appropriations limit for fiscal year 2016-2017 for the RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Directors of the RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT, in regular session assembled on July 12, 2016 at 9:00 am in the meeting room of the Board of Directors, located on the 1st floor of the County Administrative Center, 4080 Lemon Street, Riverside, California, as follows:

Section 1: That it is hereby found and determined that the documentation used in the determination of the appropriations limit for the RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT for fiscal year 2016-2017 was available to the public in the District Office of said District at least fifteen days prior to this date.

Section 2: That the growth in <u>CALIFORNIA PER CAPITA INCOME AND COUNTY</u>

WIDE POPULATION was selected for the 2016-2017 fiscal year.

Section 3. That the appropriations limit for the RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT as established in accordance with Section 7902(b) of the California Government Code is \$98,791,395.
