A United States Veteran, "Colonel Tom" proudly served thirty-three years in the Army, World War II, Korea, Vietnam, Laos, the Congo, and Iran. He was awarded many distinguished honors including the World War II Victory Medal, National Defense Service Medal with Oak Leaf Cluster, Bronze Star with Oak Leaf Cluster, Legion of Merit with Oak Leaf Cluster, Vietnam Cross of Gallantry with Palm, Vietnam Honor Medal, and Senior Parachute Badge.

Leading the way in understanding the threats of terror, Colonel Tom set a strong foundation for what has become today's Special Operations Command. His desire to develop an anti-terror and counter-terror attack force was spurred when he was almost assassinated by a briefcase bomb in Iran while serving as the Shah of Iran's Military Advisor. He did the briefing outlining the reasons for needing forces to fight our enemies which became known as DELTA FORCE. His name is engraved on the Legacy Wall at MacDill in Florida, Special Operations Command. He also predicted in a speech the possible evil actions of Sadamn Hussein in Iraq one day before Hussein invaded Kuwait in the 1990's. His prediction led to many television and radio interviews.

An instrumental force in the community, Colonel Tom was a founding docent of the Palm Springs Air Museum. The Board of Supervisors of Riverside County honored him in 2008 as a recipient of the "David Goldware Friend of the Veteran Award" for his efforts to help Veterans in Riverside County. In 2011, he was honored with the 337th Golden Palm Star on the Palm Springs Walk of Stars LA Plaza. He worked with Congressman Sonny Bono with Veteran's affairs and helped to bring excelled Nugs out of China to safety here in the United States. In 2015, he was inducted into the Ranger Hall of Fame.

Colonel Tom was a loving and devoted husband, father, step-father, grandfather, great-grandfather, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
