BACKGROUND:

Summary

While there is no one definition of "Public Works", it generally fits into a "broad category of infrastructure projects, financed and constructed by the government, for recreational, employment, and health and safety uses in the greater community. They include public buildings, transportation infrastructure, flood control facilities, solid waste facilities, airports, certain public services (construction & engineering) and other physical assets and facilities.

Many counties, including all our neighboring counties (Imperial, Los Angeles, Orange, San Bernardino, and San Diego) have established a single Public Works Department to oversee a variety of these services in a unified structure (see attachment for examples of agencies included in various public works agencies in California and neighboring states). Riverside County has historically operated under a different structure, with separate (and sometimes silo like) independent Transportation, Waste Resources, Flood Control, and Parks agencies and districts, among others.

A unified Public Works Department has the potential to achieve a variety of efficiencies and economies of scale in purchasing, maintaining, and sharing a variety of equipment, facilities, and personnel. This proposal would direct the Executive Office to research and report back on: 1) Whether pursuing a Public Works consolidation could result in budget savings to the county, 2) What agencies, departments or districts could or should be a part of such a department, and 3) What steps would need to be taken to accomplish that goal.

Departments, agencies, districts and divisions that could be considered might include, but are not limited to: Transportation, Waste Resources, Flood Control & NPDES, Regional Parks, Cemeteries, Facilities Management, Project Management, Real Property & CSA Management.

Impact on Residents and Businesses:

Studying the potential for creating a Public Works Department may identify cost savings and efficiencies that could help protect critical services from budget cuts.
